This Indenture, made this 21st day of December, 1979,
between CENTRAL NATIONAL BANK IN CHICAGO, a corporation duly organized and existing as a national banking association under the laws of the United States of America, and duly authorized to accept and execute trusts within the State of Illinois, not personally but as Trustee under the provisions of a deed or deeds in trust duly recorded and delivered to said national banking association in pursuance of a certain Trust Agreement, dated the 23rd day of January, 1978, and known as Trust Number 23333, party of the first part, and Claude Hampton, alias, ~~MacDonald~~, 3930 N. Pine Grove, Chicago, IL 60613, party of the second part.

WITNESSETH, that all of the first part, in consideration of the sum of Ten and no/100 Dollars, and other good and valuable considerations in hand paid and freely given, sell and convey unto said party of the second part, the following described real estate, situated in Chicago, Illinois, to-wit:

Unit No. 1 is in the Lake Park Plaza Condominium, as delineated on a survey of the following described lots, to-wit: Lots 1 and 2 in Block 2 in the Fairview Trust Company's Subdivision of Lots 1 and 2 in Pine Grove, a subdivision of Fractional Section 11, Township 14 North, Range 14 East of the Third Principal Meridian in Cook County, Illinois. This Survey is attached as Exhibit A to the Description of Condominium property as contained garnish therewith, and its undivided interest is reflected in the various elements.

None of the first part is hereby retained by parties of the second part, their successors or assigns, as trustee, to whom it is transferred, to the above described real estate, the title to and ownership of which consists of said property set forth in the aforementioned description of lots 1 and 2 in the first part relatives to itself, its successors and assigns, to be held and used by him in said Condominium for the benefit of the occupants of the above described real estate.

This shall be subject to all valid and unexpired restrictions, covenants, agreements and conditions of record in or affecting the same as though the premises of the above described real estate were located in Cook County, Illinois.
