in hand paid, and of other good and valuable considerations, receipt of which is hereby duly acknowledged, Convey-
and Warrant unto AMERICAN NATIONAL BANK AND TRUST COMPANY OF CHICAGO, a national banking
association as Trustee under the provisions of a certain Trust Agreement, dated the 11th
day of April 19 74, and known as Trust Number 32728, the following
described real estate in the County of COOK and State of Illinois, to wit:

Lot 39 in Block 32 in Southfield being a subdivision of Blocks 17, 18, 19, 22, 23, 24, 26, 27, 28, 29, 30, 31 and 32 in L. Stinson's Subdivision of E. Grand Crossing in the Southwest 1/4 of Section 25, Township 38 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois.

TO HAVE AND TO HOLD the said real estate with the appurtenances, upon the trusts and for the uses and purposes herein and in ~~the~~ ^{the} Settlement Agreement set forth.

This conveyance is made upon the express understandings and conditions that neither the National Bank and Trust Company of Chicago, individually or as Trustee, nor his successor or successors in trust shall incur any personal liability or be subject to any claim, judgment or decree for anything it or they or his or their agents or attorneys may do or omit to do in or about the said real estate as under the provisions of the Deed or said Trust Agreement or any amendment thereto, or any contract, agreement or understanding incurred or entered into by the Trustee in connection therewith, except that no real estate may be entered into by it in the name of the beneficiaries under said Trust Agreement as their attorney-in-fact, hereby irrevocably authorizing for such purposes, or at the election of the Trustee, in its own discretion, the Trustee or any attorney-in-fact of the Trustee, or any agent or employee of the Trustee, with respect to any sum so entered into, or any other amount which may be due and payable to the Trustee, shall be payable to the Trustee, and the payment and discharge thereof, All persons and corporations whomsoever and whatsoever shall be charged with notice of this condition from the date of the filings for record of this Deed.

The interest of each and every beneficiary hereunder and under said Trust Agreement and of all persons holding under them or any of them shall be conclusively declared to be personal property, and no beneficiary hereunder shall have any title or interest, legal or equitable, in or to said real estate as such, but only an interest in earnings, available and proceeds thereof in and to all of the real estate above described.

If the title to any of the above real estate is now or hereafter registered, the Registrar of Titles is hereby directed not to register or note in the certificate of title or duplicate thereof, or material, the words "In trust," or upon condition, or "with limitations," or words of similar import, in accordance with the entries in each case made and provided.

And the said grantor..... hereby expressly waives..... and releases..... any and all right or benefit under and by virtue of any and all statutes of the State of Illinois providing the exemption of homesteads from sale on execution or otherwise.
