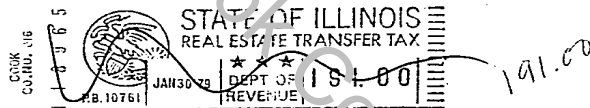
This Indenture, Made this 11th day of November, 19 78
