Unit No. 6G (the "Unit") as delineared on the Plat of Survey of the following described real estate (collective y the "Parcel"):

PARCEL 1: Lots 5 and 6 in Block 3 in Weller's Addition to Buena Park in Fractional Section 16, Township 40 North, Range 14, East of the Third Principal Meridian,

PARCEL 2: Sub Lots 26 and 27 in Waller's Subdivision of Lot 7 in Block 3 and Lot 7 in Block 4 in Waller's Addition to Buena Park in Fractional Section 16, Township 40 North, Range 14, East of the Third Principal Meridian, and


