 Affiant resides at 9635 South Winchester, Chicago, Illinois, 60643.

2. That le is an agent of grantor in a deed dated the 29 day of December 1978, conveying the following described premises:

The East 429.25 feet of the West 665.89 feet of that part of +% South West 1/4 of the South East 1/4 of section 28, Township 37 North, Range 13 East cl the Third Principal Meridian lying Southerly of the Southerly right of way line of the Northern Illinois Toll Highway as occupied and monumented, and Northerly of the Sanitary Pistrict of Chicago property (except that part taken for 127th Street) in Cook County, Illinois.

3. That the instrument aforeshir is exempt from the provisions of "An Act to Revise the Law ir Telation of Plats" approved March 31, 1874, as amended, for the reason that:

"The instrument effects a division of land into 2 parts, each of which is five acres or more in size, and does not involve any new streets or easements of access."
