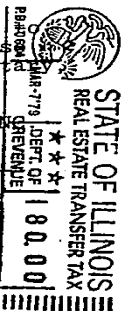

EXHIBIT A

That part of Blocks 11 and 12 in Baldwin's Subdivision of the Northwest Quarter of Section 33, Township 39 North, Range 13 East of the Third Principal Meridian in Cicero, Cook County, Illinois described as follows:

Beginning at a point on the North line of West 34th Street 510 feet Easterly of the East line of Central Avenue, as measured along said North line, said point being the Southeasterly corner of a parcel of land conveyed to Northern Wire and Strip Mills, Inc. by deed dated December 5, 1975;

Thence Easterly, along said North line of West 34th Street, 340 feet, more or less, to a point being the Southwesterly corner of a parcel of land conveyed to National Jockey Club by deed dated December 6, 1974;

Thence Northerly, at a right angle, along the Westerly property line of said National Jockey Club, 266 feet to the Northwesterly corner thereof;

Thence Northwesterly, in a straight line, 345 feet, more or less, to the Northeasterly corner of said Northern Wire and Strip Mills parcel, said point being on a line perpendicularly Northerly from the point of beginning when measured at right angles to said North line of West 34th Street;

Thence Southerly, along said perpendicular line, being the Easterly property line of said Northern Wire and Strip Mills, to the point of beginning.
