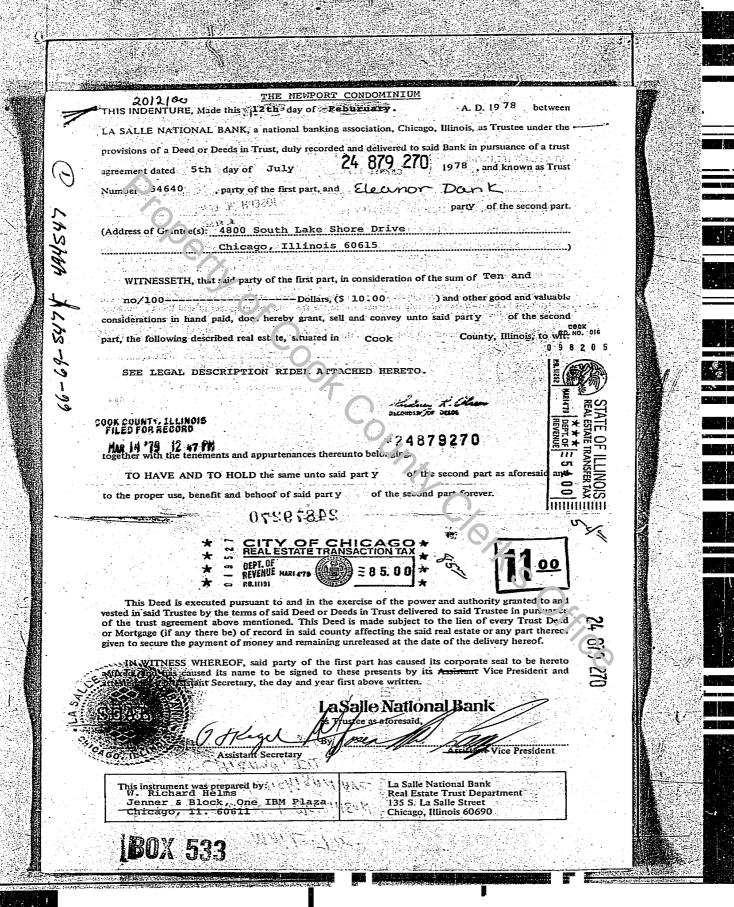

TRUSTEE'S DEED

LEGAL DESCRIPTION RIDER FOR THE NEWPORT CONDOMINIUM

#### Parcel 1:

U.IT 265 in The Newport Condominium, as delineated on the survey of the following described real estate: Block 1 in Chicaco Beach Addition, being a Subdivision of Lot "A" in Beach Lot 1 Company's consolidation of certain tracts in fractional Sections 11 and 12, Township 38 North, Range 14, East of the Third Principal Meridian (excepting from said Block 1 Lnat part thereof which lies Northeasterly of a line 40 feet Southwesterly from and parallel to the Northeasterly line of said Pick) (said parallel line being the arc of a circle having a radius of 1568.16 feet convex Southwesterly), in Cook County, Illinois; which survey is attached as Exhibit "D" to the Declaration of Condominium recorded in the Office of the Recorder of Dods of Cook County, Illinois, as Document No-24730609, tigether with its undivided percentage interest in the Common Plements.

### Parcel 2:

Together with a non-exclusive Gurage Right No. NOTE, a Limited Common Element, consisting of the right to park one passenger automobile in the Garage, which carage is delineated on the survey attached to the Declaration of Condominium aforesaid.

If the word "NONE" appears in Par 1 2 above, then no Garage Right is assigned to the Unit by this instrument.

Grantor also hereby grants to Grantee his successors and assigns, as rights and easements appurtenant to the above real estate, the rights and easements for the benefit of said property set forth in the aforementioned Declaration of Condominium; and Grantor reserves to itself, its successors and assigns, the rights and easements set forth in said Declaration of Condominium for the benefit of the remaining property describe therein.

This Trustee's Deed is subject to all rights, easements, restrictions, conditions, covenants and reservations contained in said Declaration of Condominium the same as though the provisions of said Declaration of Condominium were recited and stipulated at length herein.

If the Grantee herein is not the tenant of the above Urit in possession, or his nominee, at the time of service of the notice of intent to convert, then such tenant has either waivel or failed to exercise the right of first refusal to purchase the Unit or had no such right of first refusal under the provisions of the Illinois Condominium Property Act or Chapter 100.2 of the Muncipal Code of Chicago.
