WITNESSETH, that said party of the first part, in consideration of the sum of ten and no/100 (\$10.00) dollars, and other good and valuable

considerations in hand paid, does hereby grant, sell and convey unto said parties of the second part, the following described real estate, situated in Cook County, Illinois, to-wit:

HULL'S SUBDIVISION OF BLOCK 51 IN CANAL TRUSTEES' SUBDIVISION OF THE NORTH 1/2 AND THE NORTH 1/2 OF THE SOUTHEAST 1/4 AND THE EAST 1/2 OF THE SOUTHWEST 1/4 OF SECTION 33, TOWNSHIP 40 NORTH, RANGE 14, EAST OF THE THIRD PRINCIPAL MERIDIAN; ALSO, ALL OF THE NORTH-SOUTH 10 FOOT ALLEY LYING EAST OF AND ADJOINING LOTS 96 THRU 102 (EXCEPT THE NORTH 20 FEET OF LOT 102) IN C. BEGINNING ON THE MOST EASTERLY LINE OF SAID TRACT AT A POINT 80.49 FEET SOUTH OF THE NORTHEAST CORNER OF SAID TRACT; THENCE SOUTH 0 DEGREES 05 MINUTES 38 SECONDS EAST, ALONG SAID MOST EASTERLY LINE 21.16 FEET; THENCE NORTH 88 DEGREES 59 MINUTES 17 SECONDS WEST 63.63 FEET; THENCE NORTH 0 DEGREES 47 MINUTES 50 SECONDS WEST 10.78 FEET; THENCE SOUTH 88 DEGREES 59 MINUTES 17 SECONDS EAST 2.46 FEET; THENCE NORTH 0 DEGREES 00 MINUTES 22 SECONDS EAST 10.38 FEET; THENCE SOUTH 88 DEGREES 59 MINUTES 17 SECONDS EAST 61.30 FEET, TO THE POINT OF BEGINNING.

EASEMENTS APPURTENANT TO AND FOR THE BENEFIT OF PARCEL I; AS SET FORTH IN THE DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS BY THE BANK OF RAVENSWOOD, TRUST NO. 2914, RECORDED ON THE 10th DAY OF JULY 1978 AS DOCUMENT NO. 24525216 WITH THE RECORDER OF DEEDS OF COOK COUNTY, ILLINOIS AND FILED FOR RECORD ON THE 10th DAY OF JULY, 1978 AS DOCUMENT NO. 3030031 WITH THE REGISTRAR OF TITLES OF COOK COUNTY, ILLINOIS.
