PARCEL 1: Out Lot A in Hazelcrest Highlands a subdivision of part of the South East quarter of Section 26, Township 36 North, Range 13 East of the Third Principal Meridian,

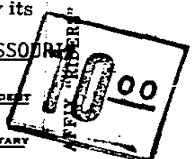
