LEGAL DESCRIPTION RIDER

Unit 388 in Central Village Condominium, as delineated on plat of sirvey of all or portions of Lot 13 in Central Village, being a subdivision of part of the Northeast Quarter (1/4) of Section 11, Township 41 North, Range 11, East of the Third Principal Meridian, in Cook County, Illinois, which plat of survey is attached as Exhibit E to Dellaration of Condominium made by Mount Prospect State Bank, a correction of Illinois, as Trustee under Trust Agreement dated December 1, 1976, and known as Trust No. 615, recorded in the office of the Pacorder of Deeds of Cook County, Illinois as Document No. 2386/15, together with a percentage of the Common Elements appurtenant to said Unit as set forth in said Declaration, as amended from time to time, which percentage shall automatically change in accordance with Amended Declarations as same are filed of record pursuant to said Declaration, and together with additional Common Elements as such Amended Declarations are filed of record in the percentages set forth in the Amended Declarations, which percentages shall automatically relemend to be conveyed effective on the recording of each such Amended Declaration as though conveyed hereby.

This deed is conveyed on the conlination that the percentage of ownership of said Grante's in the Common Elements shall be divested pro tanto and vest in the Grantees of the other Units in accordance with the terms of said or claration and any Amended Declarations recorded pursuant thereto, and the right of revocation is also hereby reserved to the Granter herein to accomplish this result.
