JUDGE'S DEED

WHEREAS, on the 1st day of May 1975, in case number 73D9827 entitled Katie Mae Bradley vs. John Wilson Bradley, petitioner was granted a judgement of Dissolution of Marriage from said John Wilson Bradley, wherein said judgement provided that John Wilson Bradley should within ten days from the date of said judgement, execute and deliver to Katie Mae Bradley, a deed conveying all his right, title and interest in the real estate hereinbelow described.

Now, therefore, know all men by these presents, that I, an Associate Judge of the Land Title Section of the Circuit Court of Cook County, Illinois, in consideration of the premises, do hereby convey and quit claim all his right, title and interest of the said John Wilson Bradley, to Katie Mae Bradley, of 7307 S. Emerald Av., Chicago, Illinois, her heirs and assigns forever, the following described premises to wit:

"The South 32 feet of Lot 29 in Block 4 in B.W. Wood's Normal Park Subdivision being a Sub-division in the Southwest quarter of the Northwest quarter of Section 28, Township 38 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois."

To have and to hold the same, with all the appurtenances thereto belonging to the said Katie Mae Bradley, her heirs and assigns forever.

This deed is executed and delivered solely in compliance with the judgement for Dissolution of Marriage hereinabove referred to.
