Dropo, ALL THAT PARCLL of land situate in the City of Chicago, County of Cook, and State of Illinois in the southeast quarter of Section 8, Township 39 No.th, Range 14 east of the Third Principal Meridian, being part of Loc. 1 to 5 inclusive in Block 2 in Carpenter's Addition to Chicago, logether with that part of Kinzie Street lying between the north 1 ne of Block 2 and a line designated as the Division Line between the lands of the Chicago Northwestern Railway Company and lands of Pitisburgh, Chicago, Cincinnati & St. Louis Railway Company as established by agreement dated February 11, 1903 and recorded February 9, 1'43 as Document No. 13028398, bounded and described according to a pin of a survey made by Emmet Kennedy and Company as follows, viz:

SUBJECT, however, to any easement, encumbrance, right or belief t that may have been created or recognized in or by that certain deed from a predecessor of the Grantor herein to Consolidated Rail Corporation, designated as Document No. PB&W-CRC-RP-7 in the certification, as amended, of United States Railway Assocation to the Special Court suant to Section 209(d) of the Regional Rail Reorganization Act of 1973, as amended, said deed not yet having been recorded.
