Trustee's Deed

THI, I'DENTURE, made this 10th day of May, A.D. 1978, between NATIONAL BOULEVARD BAN. OF CHICAGO, a national banking association, of Chicago, Illinois, as Trustee under the provisions of a deed in trust, duly recorded and delivered to said Bank in pursuance of a trust agreement dated the 12th day of August, 1977, and known as must Number 5854 ("Grantor"), and

WITNESSETH, that Greater, in consideration of the sum of Ten and No/100 bollars (\$10.00) and other great and valuable considerations in hand paid, does hereby grant, sell, and convey unto Grantee, not as tenants in common, but as joint tenants, the following decreated real estate, together with the tenements and appurtenances thereunto belonging, situated in Cook County, Illinois, to wit:

Unit No. 3L (the "Unit") as delineated on the Plat of Survey of the following described real estate (collectival, the "Parcel"):

PARCEL 1: Lots 5 and 6 in Block 3 in Walter's Addition to Buena Park in Fractional Section 16, Township 40 North, Farze 14, East of the Third Principal Meridian,

PARCEL 2: Sub Lots 26 and 27 in Waller's Subd vision of Lot 7 in Block 3 and Lot 7 in Block 4 in Waller's Addition to Brown Park in Fractional Section 16, Township 40 North, Range 14, East or the Third Principal Meridian, and

PARCEL 3: Lots 5, 6, 7, and 8 and that part of Lot 2. 1 ing between the East line of Lot 4 extended North and the East line of Lot 5 extended North, being that portion of Lot 25 lying North of and acioning Lots 5, 6, 7, and 8, all in Simmons and Gordon's Addition to Chicage, bing a subdivision of Lots 10 and 19 and the vacated street lying between 1 said lots in the School Trustees Subdivision of Fractional Section 15, Township 40 North, Range 14, East of the Third Principal Meridian,

which Survey is attached as Exhibit A to the Declaration of Condominium Ower-lip made by Grantor, recorded in the Office of the Recorder of Deeds of Cook (ount), Illinois, as Document No. 24491225 and registered in the Office of the Registrar of Torrens Titles of said County as Document No. 3024350, together with an undivided 435 percent interest in the Parcel (excepting from the Parcel all the property and space comprising all the Units thereof as defined and set forth in said Declaration and Survey).

Grantor further specifically grants to Grantee and Grantee's successors and assigns, as rights and easements appurtenant to the Unit, the rights and easements for the benefit of the Unit set forth in the aforesaid Declaration, and Grantor reserves to itself and its successors and assigns the rights and easements set forth in said Declaration for the benefit of the remaining property described therein.

TO HAVE AND TO HOLD the same unto Grantee, not in tenancy in common, but is joint tenancy, and to the proper use, benefit, and behoof of Grantee forever.

This instrument is made subject to encroachments; building lines, conditions of the aforesaid Declaration and all amendments, if any, thereto; private, public, and utility easements, including all easements established by or implied from said Declaration or any amendments thereto; limitations and conditions imposed by the Condominium Property Act of the State of Illinois or Chapter 100.2 of the Municipal Code of Chicago; general real estate taxes for the year 1977 and subsequent years; installments due after the date of the delivery of this instrument of assessments established pursuant to said Declaration;
