

Unit 36-B in malsea Cove Condominium No. 1 as delineated on survey of a part of Lot 1 in "Chelsea Cove", a subdivision, being part of Lots 5, 6 and 7 taken as a tract, in Owner's Division of Buffalo Creek'Farm, being a subdivision of part of Sections 2, 3, 4, 9 and 10, Township /2 North, Range 11 East of the Third Principal Meridian in the Vi'lage of Wheeling, Cook County, Illinois according to the Plat thereous recorded January 31, 1973, as Document No. 22205368 in Cook County, Illinois, which survey is attached as Exhibit B to Declaration of Condominium Ownership made by American National Bank and Trust Company of Chicago, as Trustee under Trust No. 77166 recorded in the Office of the Recorder of Deeds of Cook County, Illinois as Document No. 22604309, together with a percentee of the Common Elements appurtenant to said Unit as set forth in said Declaration, as amended from time to time, which percentee shall automatically change in accordance with Declarations as some are filed of record pursuant to said Declaration, and togeths with additional Common Elements as such Amended Declarations are filed of record; in the percentages set forth in such Amended Declarations, which percentages shall automatically be deemed to be convoyed effective on the recording of each such Amended Declaration is though conveyed hereby.

This deed is given on the conditional limitation that the percentage of ownership of said Grantees in the Common Elements shall be divested <u>pro\_tanto</u> and vest in the Grantees of the other units in accordance with the terms of said Declaration and any Amended Declarations recorded pursuant thereto, and right of revocation is hereby reserved to the Grantor herein to accomplish this result. The acceptance of this conveyance by the Grantees shall be deemed an agreement within the contemplation of the Condominium Property Act of the State of Illinois to a shifting of the Common Elements pursuant to said Declaration and to all the other terms of said Declaration, which is hereby incorporated herein by reference thereto, and to all the terms of each Amended Declaration pursuant thereto.

This deed is subject to all rights, easements, restrictions, conditions, covenants and reservations contained in said Declaration the same as though the provisions of said Declaration were recited and stipulated at length herein.
