Subject to Taxes, 1978 and subsequent years and conditions and covenant of record and REPURCHASE AGREEMENT: The buyer, by the execution of this deed hereby warrants to the seller the irrevocable right of first refusal to purchase the property if the seller should hereafter decide to sell this realty as his residence or as a second home, or if he should hereafter decide to lease and occupy the property from date of delivery of the deed, at the price paid for said property by the buyer, grantee herein, to the seller, the contractor."


