Grantor also hereby grants to Grantee, their successors and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of said property set forth in the Declaration of Condominium, aforesaid, and in the Declaration of Covenants, Conditions, Restrictions and Easement recorded as Document 23667054, as supplemented by Document 2465504, and Grantor reserves to itself, its successors and assigns, the Rights and Easements set forth in said Declarations for the benefit of the remaining property described therein.
