(d) to keep the premises free from liens of mechanics and materialmen, and from all other liens, charges, or encumbrances prior to or on a parity with the lien of this Trust Deed;

(e) to permit the Trustee or holder(s) of the Note access to the premises at all reasonable times for purposes of inspection;

In case of the resignation, inability or refusal to act of The First National Bank of Chicago, as Trustee, at any time when action hereunder may be required by any person entitled thereto, then the Chicago Title and Trust Company shall be and it is hereby appointed and made successor in trust to The First National Bank of Chicago, as Trustee under this Trust Deed, with identical powers and authority, and the title to said Mortgaged Property shall thereupon become vested in such successor in trust for the uses and purposes aforesaid.
