To have and to hold the same, with all the appurtenances thereto belonging to the said BILLY C. HENTON, his heirs and assigns forever.

This deed is executed and delivered solely in compliance with the judgment for Dissolution of Marriage hereinabove referred to.

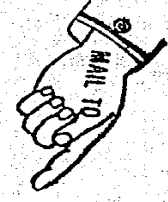
