RIDER ATTACHED TO AND MADE A PART OF TRUSTEE'S DEED FROM AMERICAN NATIONAL BANK AND TRUST COMPANY OF CHICAGO, NOT PERSONALLY BUT SOLELY AS TRUSTEE PURSUANT TO TRUST AGREEMENT DATED AUGUST 23, 1973 AND KNOWN AS TRUST NO. 32211, TO HAROLD GOTTHELF and RUTH GOTTHELF

A.

Notwithstanding anything contained in the Trustee's Deed to which this Rider is attached, IT IS HEREBY AGREED AS FOLLOWS:

- a). - The legal description of the property being conveyed is as follows:
- Lot 209 in Ancient Tree Unit One-H, being a resub-division of parts of Lots 1003 and 2016 and a part of Lot 2018 in Ancient Tree Unit One, being a sub-division of parts of the Northeast one-quarter of the Southwest one-quarter and the Southeast one-quarter of the Northwest one-quarter of Section 8, Township 42 North, Range 12, East of the Third Principal Meridian, in Cook County, Illinois;
- b). Grantor hereby grants to Grantees, their heirs, executors, administrators, grantees, legal representatives, successors and assigns, as the case may be, as rights and easements appurtenant to the above-described real estate, the rights and easements for the benefit of said property set forth in:
- i). Plat of Subdivision of Ancient Tree Unit One, recorded in the Office of the Recorder of Deeds of Cook County, Illinois on May 17, 1973 as Document Number 22328735;
  - ii). Declaration of Easements, Covenants and Restrictions, recorded in the Office of the Recorder of Deeds of Cook County, Illinois on May 21, 1974 as Document Number 22723117;
  - iii). Plat of Subdivision of Ancient Tree Unit One-II, recorded in the Office of the Recorder of Deeds of Cook County, Illinois on October 13, 1977 as Document No. 24145958;
- and Grantor reserves to itself, its successors and assigns, the rights and easements set forth in the aforesaid Declaration and Plats of Subdivision for the benefit of the remaining property described therein;
- c). This Deed is subject to all rights, easements, restrictions, conditions, covenants and reservations contained in said Declaration and Plats of Subdivision, the same as though the provisions of said Declaration and Plats of Subdivision were recited and stipulated at length herein.
