Mortgagors shall (a) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become do or be destroyed; (b) keep said premises in good condition and repair, without waste, and free from mechanic's or other liens or claims for lien pressly subordinated to the lien hereof; (c) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to holders of the note; (d) complete within mable time any building or buildings now or at any time in process of erection upon said premises; (e) comply with all requirements of law or pall ordinances with respect to the premises and the use thereof; (f) make no material alterations in said premises except as required by law or pall ordinance.
