JUDGE'S DEED

The West half of Lot 8, all of Lot 9 in Block 6 in Mitchell's Addition to Clarkdale, a Subdivision of the North half of the South East quarter of Section 35, Township 38 North, Range 13 East of the Third Principal Meridian in Cook County, Illinois.

To have and to hold the same, with all the appurtenances thereto belonging to the said IRENE MEDINA, her heirs and her assigns forever.

This deed is executed and delivered solely in compliance with the Judgment for Dissolution of Marriage hereinabove referred to.
