





Plaintiff is in possession of, and entitled to enforce, a Loan Agreement dated June 15, 2022, in the principal amount of \$40,000.00 with interest accruing at the Prime Rate plus 2.58% per annum (the "Agreement") executed by Defendant Quickway Services, LLC ("Borrower"). Pursuant to the terms of the Agreement, Plaintiff exercised its rights to accelerate the Agreement upon demand such that the entire balance was due and owing and institute the default rate of

interest (contract rate plus 5% per annum or Prime Rate + 7.58% per annum).

- 3. Borrower failed to pay the balance due and owing under the Agreement.
- 4. Borrower owes Plaintiff on the Agreement the principal amount of \$29,472.53, plus accrued but unpaid interest in the amount of \$2,007.32 as of May 26, 2023, plus late fees of \$60.00, plus interest that continues to accrue thereafter at the default rate of the Prime Rate + 7.58% per annum, plus accruing fees and the costs of this action, including attorneys' fees incurred by Plaintiff.

- 8. Defendants are in default for failing to answer or otherwise defend against the Complaint as required by Civ.R. 12(A), and thereby confess the allegations of the Complaint to be true.
- 9. That, pursuant to the terms of the Agreement and Guaranty, Defendants are obligated to reimburse Plaintiff for all costs of collection, including expenses, incurred by Plaintiff
