### TRUSTEE'S DEED

Subject to general taxes for 1976 and subsequent years; party wall rights and agreements, if any, existing leases and tenancies; covenants, conditions and restrictions of record; public and utility easements; and all building and zoning laws and ordinances.

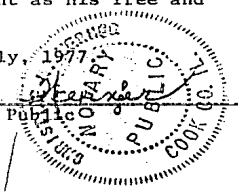

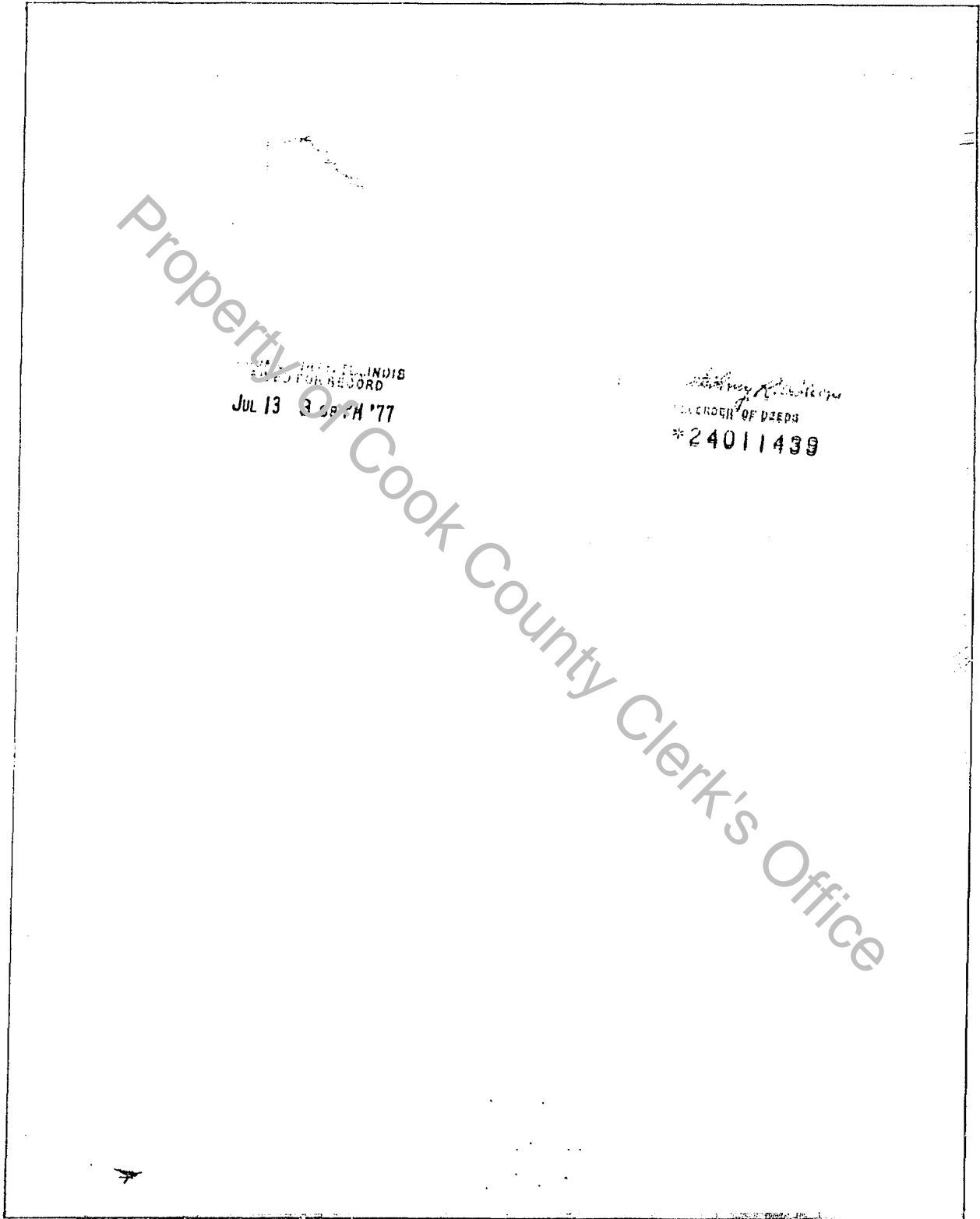
