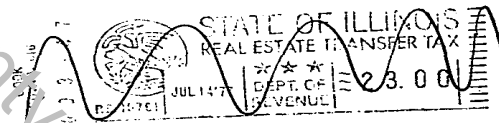
Trustee's Deed Joint Tenancy

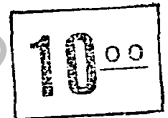

Subject to restrictions and conditions of record.

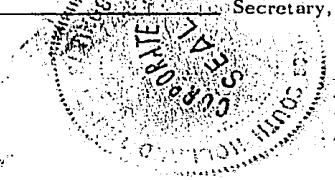
