materials, fixtures, apparatus, and machinery relative to the construction of condominiums on the LAND.

- 3. The Contract was entered into and the labor, services, materials, fixtures apparatus, and machinery were provided with the knowledge and consent of the Owner. Alternatively, Owner authorized the contract and extras or knowingly permitted such contracts and extras for the improvement of the LAND.
- 4. That from January 1, 2022 through December 31,2023 the Claimant provided labor, services, materials, fixtures, apparatus, and machinery relative to the improvement of the Property that enhanced its value. The Claimant has been paid \$2,785,118.30 to date.
- 5. After allowing for all credits and amounts due, the sum of \$2,906,137.81 remains due and owing, for which, with interest and attorney's fees allowed by contract and statute, the Claimant claims a lien on said LAND and improvements.
- 6. The Claimant last delivered materials, to and provided labor, services, materials, fixtures, apparatus, and machinery for the improvement of the real property on September 15, 2023.
- 7.
