### AMENDMENT TO THE BYLAWS OF THE GROVE VICTORIAN CONDOMINIUMS

THIS AMENDMENT TO THE BYLAWS OF THE GROVE VICTORIAN CONDOMINIUMS (this "Amendment") is made and entered into as of the \( \frac{15}{3} \) day of January, 2024 by the Board of Managers of the THE GROVE VICTORIAN CONDOMINIUMS ("Association").

### RECITALS:

WHEREAS, a Declaration of Condominium Ownership, Bylaws, Easements Restrictions, and Covenants for The Grove Victorian Condominiums was recorded on December, 23, 2005 as Document No. 0535745030 in the Office of the Recorder of Deeds of Cook County Itlinois (the "Declaration"), governing certain property legally described on Exhibit A attached hereto and located at 111 South Grove Avenue, Oak Park, Illinois 60302, pursuant to the provisions of the Condominium Property Act of the State of Illinois (765 ILCS 605/1 et seq.) (the "Act"). Capitalized terms not expressly defined herein shall have the meaning ascribed to such terms in the Declaration and Bylaws;

WHEREAS, the Association desires to amend the Bylaws in the manner more particularly described herein.

NOW THEREFORE, the Bylaws are hereby amended as follows:

Article IV, Section 2(c) of the Association Bylaws contained within Exhibit C of 1. the Declaration is hereby amended by adding the following the following paragraph:

> In order to maintain a uniform appearance of the building exteriors, any replacement window shall match the exterior color, style, and material of corresponding windows on other parts of the building (i.e. a replacement kitchen window, for example, shall match the kitchen windows on other Units). A Unit Owner may elect to replace windows in their Unit at their own expense, in which case such replacement shall include the re-lacement/repair of any part of the Common Elements that are impacted by such replacement. In the event a Unit Owner so elects to replace a window in their Unit at their own expense (except when the need for the repair or replacement is due to the act or omission of a Unit Owner, guest, occupant, family member, or pet) and the Association votes to replace the corresponding window in another Unit within three (3) years of the individual Unit Cwier's replacement of their window, the Association shall reimburse the individual Unit Owner for their reasonable and necessary costs/expenses incurred in replacing such window, so long as that Unit Owner remains a Unit Owner at the time of the Association's vote.

All references in the Declaration or Bylave to the Bylaws shall mean the Bylaws as amended hereby. Except as otherwise expressly amended by this Amendment, the Bylaws shall -10/4's Office remain in full force and effect.
