





1. This Court has jurisdiction over the parties and subject natter herein. All necessary parties for a complete adjudication have been served with a summons and copy of the Complaint according to law as follows:

2. Plaintiff is in possession of, and entitled to enforce, a Loan Agreement dated February 8, 2022, in the principal amount of \$100,000.00 with interest accruing at the Prime Rate plus 2.61% per annum (the "Agreement") executed by Defendant M & M Development Midwest Inc. ("Borrower"). Pursuant to the terms of the Agreement, Plaintiff exercised its rights to

accelerate the Agreement upon demand such that the entire balance was due and owing and institute the default rate of interest (Prime Rate + 7.61% per annum).

- 3. Borrower failed to pay the balance due and owing under the Agreement.
- 4. Borrower owes Plaintiff on the Agreement the principal amount of \$84,561.63, plus accrued but unpaid interest in the amount of \$2,751.71 as of June 16, 2023, plus bank fees of \$25.00, plus interest that continues to accrue thereafter at the default rate of the Prime Rate + 7.61% per amuse plus accruing fees and the costs of this action, including attorneys' fees incurred by Plaintiff.
- 5. As inducement for Plaintiff to extend the credit evidenced by the Agreement, Defendant Lucius McGhee ("Guaranto") executed a Guaranty of Loan Agreement dated February 8, 2022 (the "Guaranty"), in which he unconditionally guaranteed payment to Plaintiff of all obligations of Borrower to Plaintiff (as defined in the Guaranty), which includes the amounts owing under the Agreement.
