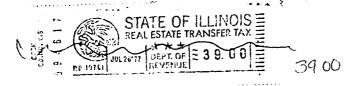
RONALD F. GUILLOZ and SANDRA S. GUILLOZ, his wife, as joint tenants and not as tenants in common,
