This is not homestead property.



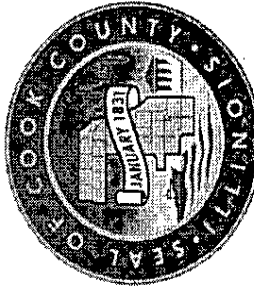
