and XXXXXX unto THE COSMOPOLITAN NATIONAL BANK OF CHICAGO, a corporation duly organized
and existing as a national banking association under the laws of the United States of America, and duly authorized
to accept and execute trusts within the State of Illinois, as Trustee under the provisions of a certain Trust Agree-
ment, dated the 28th day of April 1966, and known as Trust Number 16182,

made to a specific, or successive, in trust, nor its successor or successors. In trust have been properly appointed at or fully vested with all the title, rights, powers, authority, dominion, obligation, and responsibility, in trust, in the Trustee.

This concession is made upon the express understanding and condition that nothing The Commonwealth National Bank of Chicago, individually or as Trustee, nor its successor or successors in trust shall incur any personal liability or be subjected to any claim, judgment or decree for anything it did or they or its or their agents or attorneys may do or omit to do in or about the said real estate or under the provisions of this Agreement or any amendment thereto, or for injury to persons or property happening or about had or to a vessel, cargo, and all such liability, including liability by strict liability, is hereby expressly and unconditionally免除 from and excluded by the Trustee in connection with said real estate, which may be entered into by it in the name of the other beneficiaries and users. The Trustee, however, shall not, in fact, hereby irrevocably appointed for such purpose, or at the election of the Trustee, in its own name, as Trustee of an express trust and not individually (and the Trustee shall have no obligation whatsoever with respect to any such contract, obligation or indebtedness), except only so far as the trust property and funds in the actual possession of the Trustee shall be applicable for the payment and discharge of such debts, obligations and corporations whomsoever and whatsoever shall be charged with notice of this condition from the date of the filing for record.

This Deed. The interest of each and every beneficiary hereunder and under said Trust Agreement and of all persons claiming under them or any of them, in and to the entire interest in the property arising from the conveyance hereinabove made, and which is hereby declared to be an interest in the estate as such, but only an interest in the earnings, assets and proceeds of which as aforesaid, the intention hereof being to vest in said Cosmopolitan National Bank of Chicago the entire legal and equitable title to the same, in and to all of the real estate above described, in the portion thereof of which the sum of \$100 is hereby directed to be paid to the Trustee, and the remainder of which is hereby directed to be registered or noted in the possession of either the donee or donee's heirs, executors, administrators, or assigns, and which shall be held by the Trustee in trust for the benefit of similar heirs, in accordance with the statute in such case made and provided, and said Trustee shall not be required to produce the said Agreement or a copy thereof, or any extracts therefrom, as evidence that any transfer, charge or other dealing involving the registered lands is in accordance with the true intent and meaning of the trust.
