TO HAVE AND TO HOLD the same unto said parties of the second part, their heirs and assigns, forever.

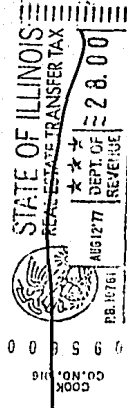

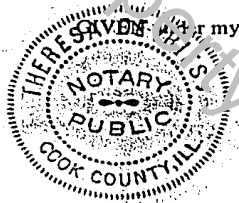
