

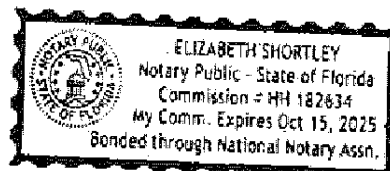

PARCEL 2:
