To Have and to Hold the same unto said party of the second part forever.

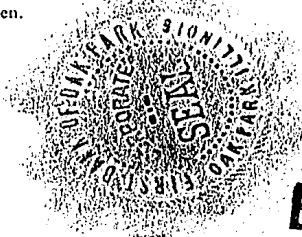
