THE FOLLOWING ARE THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 1 (THE REVERSE SIDE OF THIS TRUST DEED) AND WHICH FORM A PART OF THE TRUST DEED WHICH THERE BEGINS:

- 1. Mortgagots shall (1) keep said premises in good condition and repair, without waste; (2) promptly repair, restore, or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (3) keep said premises free from mechanics liens or tiens in favor of the United States or other liens or claims for lien not expressly subordinated to the lien hereof; (4) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to holders of the note; (5) complete within a reasonable time any buildings now or at any time in process of crection upon said premises; (6) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (7) make no material alterations in said premises except as required by law or municipal ordinance or as previously consented to in writing by the Trustee or holders of the note.
- 2. Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall, upon written request, furnish to Trustee or to holders of the note the original or duplicate receipts therefor. To prevent default hereunder Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagors may desire to contest.
- 3. Mortgagors shall keep all buildings and improvements now or hereafter situated on said premises insured against loss or damage by fire, lightning and windstorm under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or reparting the same or to pay in full the indebtedness secured hereby, all in companies satisfactory to the holders of the note, under minutinee policies payable, in case of loss or damage, to Trustee for the benefit of the holders of the note, such rights to be evidenced by the standard mort gage clause to be attached to each policy, and shall deliver all policies, including additional and renewal policies to holders of the note, and in case of insurance about to expire, shall deliver renewal policies not less than ten days prior to the respective dates of expiration.
- 4. In case of default therein, Tristee or the holders of the note may, but need not, make any payment or perform any act hereinbefore required of Mortgage. In any torm and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on from any tax as you to be ferror, and purchase, discharge, compromise or settle any tax lien or other prior lien or title or claim thereof, or redeem from any tax sat or to be ferror, and purchase or comest any tax or assessment. All moneys paid for any of the purposes herein authorized and all expenses pair or incurred in connection therewith, including reasonable attorneys fees, and any other moneys advanced by Trustee or the holders of the note to a teet the mortgaged premises and the lien hereof, plus reasonable compensation to Trustee for each matter concerning which action herein gather set on the taxen, shall be so much additional indebtedness secured hereby and shall become immediately due and payable without notices of d with interest thereon at the rate of seven per cent per annum. Inaction of Trustee or holders of the note shall never be considered as a waive of any right accruing to them on account of any default hereumder on the part of Mortgagors.
- 5. The Trustee or the 'olde's of the note hereby secured making any payment hereby authorized relating to taxes or assessments, may do so according to any bill, state 'or' estimate procured from the appropriate public office without inquiry into the accuracy of such bill, statement or estimate or into the valid's, or any tax, assessment, sale, forfeiture, tax lien or relatin thereof.

 6. Mortgagors shall pay each ter's of indebtedness herein mentioned, both principal and interest, when due according to the terms hereof. At the election of the holders of the rine, al note, and without notice to Mortgagors, all unpaid indebtedness secured by this Trust Deed shall, notwithstanding anything in the principal not of or in this Trust Deed to the contrary, become due and payable when default shall occur in payment of principal or interest, or in case default, shall occur and continue for three days in the performance of any other agreement of the Mortgagors herein contained.
- 7. When the indebtedness hereby secured s'm become due whether by the terms of the note described on page one or by acceleration or otherwise, holders of the note or Trustee shall here the right to foreclose the lien hereof and also shall have all other rights provided by the law of Illmois for the enforcement of a mortgage detailed to the content of the content of a mortgage detailed to the content of the c
- 8. The proceeds of any foreclosure sale of the premises shall be distributed and applied in the following order of priority: First, on account of all costs and expenses incident to the foreclosure proceedings, including all yiels it in as as are mentioned in the preceding paragraph hereof, see ond, all other items which under the terms hereof constitute secured indebted sess additional to that evidenced by the note bereby secured, with interest thereon as herein provided, third, all principal and interest remaining inc. ar', c with, any overplus to Mortgagors, then heirs, legal representatives or assigns as their rights may appear.
- 9. Upon or at any time after the filing of a complaint to foreclose this Turst Deed the Court in which such complaint is filed may appoint a receiver of said premises. Such appointment may be made either before or after sale, wit our notice, without regard to the solveney or insolveney of Mortgagors at the time of application for such receiver and without regard to the thor, all a fit the premises or whether the same shall be then occupied as a homesterad or not and the Trustee hereinder may be appointed as such receiver. - 13. Trustee shall release this Trust Deed and the line thereof by proper instrument upon presentation of satisfactory codence that all indebtedness secured by this Trust Deed has been fully paid; and Trustee may execute and deliver a release hereof to and at the ragues of any person who shall either before or after maturity thereof, produce and exhibit to Trustee the principal note, representing that all indee edness hereby secured has been paid, which representation Trustee may accept as true without inquiry. This Trust Deed and all provisions hereof, shall extend to and be binding upon Mortgagors and all persons claiming under or through tpagors, and the word "Mortgagors" when used herein shall include all such persons and all persons at any time liable for the payment of indebtedness or any part thereof, whether or not such persons shall have executed the principal note, or this Trust Deed.

FOR THE PROTECTION OF BOTH THE BORROWER AND LENDER, THE NOTE SECURED BY THIS TRUST DEED SHOULD BE IDENTIFIED BY THE TRUSTEE, BEFORE THE TRUST DEED IS FILED FOR RECORD.
