

MORIGAGE AND SECURITY AGREEMENT WITH COLLATERAL ASSIGNMENT OF LEASES AND RENTS [RECOURSE] LOAN #: 8420-02092

THIS MORTGAGE AND SECURITY AGREEMENT WITE COLLATERAL ASSIGNMENT OF LEASES AND RENTS (this "mortgage") dated 4/9/2024, bety eca., 408 AUSTIN CORPORATION AND STACER INC., ILLINOIS CORPORATIONS, (the "Mortgagor" and COMMUNITY INVESTMENT CORPORATION having its principal place of business at 222 South Riverside Plaza, Chicago, IL 60606 ("Mortgagee" herein).

RECITALS

WHEREAS, Mortgagor 408 AUSTIN CORPORATION AND STACER INC., ILLINOIS CORPORATIONS, (the "Mortgagor" AND herein) has executed and delivered to Mortgagee, a Fixed Rate Note of even date herewith in the principal amount of EIGHT HUNDRED AND FIVE THOUSAND AND NO/100 Dollars (\$805,000.00), which bears interest at the rate, and is payable in installments and on the dates, provided for therein, with a final payment, if not sooner paid, c. 11/2027, and which note together with all notes delivered in substitution or exchange therefor are hardness recollectively called the "Note;" and

WHEREAS, Mortgagee requires that the prompt payment of the Note, including the interest due in accordance with the terms thereof, and any additional indebtedness accruing to Mortgagee pursuant to the Note, be secured by this Mortgage.

NOW, THEREFORE, Mortgagor to secure payment of the indebtedness due or to become due pursuant to the Note, this Mortgage, and the performance of the covenants herein and therein contained to be performed, kept and observed by Mortgagor and/or Co-Borrower, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged does hereby MORTGAGE, GRANT and CONVEY unto Mortgagee, its successors and assigns, the real estate situated in the City of OAK PARK, County of COOK, and State of Illinois, as more particularly described in Exhibit A attached hereto and made a part hereof.

TOGETHER with all easements, rights of way, licenses, privileges, tenements, hereditaments and appurtenances belonging thereto and all rents, issues, proceeds and profits therefrom, including all right, title, estate and interest of Mortgagor therein at law or in equity;

TOGETHER with all buildings, structures and improvements now or hereafter erected thereon and all materials intended for construction, reconstruction, alteration and repair of such buildings, structures and improvements now or hereafter erected thereon, all of which materials shall be deemed to be included within the real estate immediately upon the delivery thereof to the premises, and also all machinery, apparatus, equipment, goods, systems and fixtures of every kind and nature now or hereafter located in or upon or affixed to said real estate or any part thereof, owned or hereafter acquired by Mortgagor and used or usable in connection with any present or future operation of the building on the real estate, including without havi ation, all heating, lighting, refrigerating, ventilating, air conditioning, air cooling, lifting, fire extinguishir.g. plumbing, cleaning, communications, and power equipment, systems and apparatus, all gas, water and electrical equipment, systems and apparatus; all engines, motors, tanks, pumps, screens, storm doors, storm vindows, shades, blinds, awnings, floor coverings, cabinets, partitions, conduits, ducts and compressors; and all items of furniture, furnishings, equipment and personal property owned by Mortgagor and used in the operation of said real estate; it being understood and agreed that all such machinery, equipment, apparatus, go vis, systems and fixtures are or will become a part of the real estate and are acknowledged to be a portion of the security for the indebtedness secured hereby and covered by this Mortgage; and as to any of the aforesaid property which does not so form a part of the real estate or does not constitute a "fixture" [as defined in the Uniform Commercial Code of the State of Illinois (the "Code")], this Mortgage is hereby deemed to be a Security Agreement under the Code for the purpose of creating a security interest in such property, which Mortgagor hereby grants to Mortgagoe as "Secured Party" (as defined in the Code); all of the foregoing, than together with the real estate, are hereinafter sometimes collectively referred to as the "Mortgaged Premises."

TO HAVE AND TO HOLD, the Mortgaged Premises and Mortgagee, its successors and assigns, forever, for the uses and purposes set forth herein. Mortgager covenants that at the time of the execution and delivery of this Mortgage it holds fee simple title to the Mortgage Premises and has the right and power, and has been duly authorized and directed, to grant, mortgage and convey the same in the manner and form herein provided; and that the Mortgaged Premises are free from all tions and encumbrances whatsoever.

THIS MORTGAGE IS GIVEN TO SECURE: (i) payment of the indebt dness secured hereby; and (ii) the performance of each and every of the covenants, conditions and agreements contained in the Note, this Mortgage or in any other instrument to which reference is expressly made in this Mortgage.

MORTGAGOR, for themselves, their successors and assigns, HEREBY COVENANT AND AGREE WITH MORTGAGEE that:

1. PAYMENT AND COMPLIANCE WITH NOTE.

Mortgagor will duly and punctually pay all principal and interest due on the Note and any late charges required thereunder, and the principal of, and interest on, any Future Advances (as hereinafter defined) secured by this Mortgage, and will otherwise comply with the terms and conditions of the Note, at the times and in the manner therein provided.

2. OTHER PAYMENTS.

Mortgagor will deposit monthly with Mortgagee or a depositary designated by Mortgagee, in addition to the monthly installments of interest or principal and interest due on the Note, and concurrently therewith, until the principal indebtedness evidenced by the Note is paid, the following:

(a) a sum equal to the amount estimated by Mortgagee as sufficient together with the payment of approximately equal installments as will result in the accumulation of a

sufficient amount of money to pay all Impositions (as hereinafter defined) falling due with respect to the Mortgaged Premises, at least thirty (30) days before the applicable due date; and

(b) a sum equal to an installment of the premium or premiums that will become due and payable to renew the insurance required under paragraph 4 hereof. Each installment shall be in an amount which, with the payment of approximately equal installments as will result in the accumulation of a sufficient sum of money to pay all renewal premiums upon such policies of insurance with respect to the Mortgaged Premises, at least thirty (30) days before the expiration date or dates of the policy or policies to be renewed.

All such payments described in this paragraph 2 shall be held by Mortgagee or the depositary designated by Mortgagee, in trust, without accruing of any obligation for the payment of interest the eon. When the indebtedness secured hereby has been paid in full, any remaining deposits shall be refunded to Mortgagor. The deposits required to be maintained hereunder are hereby pledged as additional security for the prompt payment of the Note and any other indebtedness secured hereby and shall be applied for the purposes herein expressed and shall not be subject to the direction or control of Mortgagor.

If the funds so deposited are insufficient to pay, when due, all Impositions or premiums as aforesaid, Mortgagor will deposit, within ten (10) days after receipt of demand therefor, such additional funds as may be recessary to pay such Impositions or Premiums. If the funds deposited exceed the amounts required to pay such Impositions or Premiums, the excess shall be applied to a subsequent deposit or deposits.

Neither Mortgagee nor any depositary designated by Mortgagee shall be liable for any failure to make the payments of insurance premium, or impositions unless Mortgager, while not in default hereunder, shall have requested Mortgagee or such depositary to make application of such deposits to the payment of the particular insurance premiums or Impositions. Notwith standing the foregoing, Mortgagee may, at its option, make or cause the depositary to make any such application of the aforesaid deposits without any direction or request to do so by Mortgagor.

PAYMENT OF TAXES.

Unless reserves have been established for such impounds, Mortgag or viall pay, or cause to be paid, all taxes, assessments, general or special, and other charges leviel on or assessed, placed, confirmed or made against the Mortgaged Premises, or which become a lieu upon or against the Mortgaged Premises or any portion thereof or which become payable with respect to reeto or with respect to the use, occupancy or possession thereof ("Impositions" herein). Mortgagor will furnish to Mortgagee a receipt evidencing payment of all applicable Impositions within sixty (or) days of the applicable due date. Mortgagor reserve the right to contest real estate tax payments provided Mortgagor gives written notice to Mortgagee of such contest and tenders to the Mortgage as the Mortgagee may require not later than ten (10) business days prior to the due date for the tax.

4. INSURANCE.

A. Mortgagor will keep and maintain, at their sole cost and expense, insurance policies with respect to the Mortgaged Premises issued by insurance companies approved by Lender and covering loss by perils, hazards, liabilities and other risks and casualties and in form and such amounts as required by Lender. Each carrier providing the insurance coverages required by this Section 4.A shall be licensed in Illinois and have a rating of at least A- or better from A.M. Best's Rating Service. Policies (or evidence of insurance printed on ACCORD Form 27) in form and amounts reasonably satisfactory to Lender, endorsed to protect Lender's interest with the standard

mortgagee clause or loss payable clause in favor of Lender, shall be delivered to Lender, together with evidence of renewals and the payment of premiums.

- (i) Mortgagor shall keep the improvements now existing or hereafter erected on Mortgaged Property insured for the "full insurable value" of the Mortgaged Property under a replacement cost form of insurance policy against loss or damage resulting from, fire, windstorms, explosions, and other hazards as may be required by Lender.
- (ii) Comprehensive liability and property damage insurance; and
- (iii) Boiler and mechanical coverage; and
- (iv) Such other insurance in amounts and against such insurable risks as Mortgagee may from time to time reasonably require,
- B. All policies of insurance required hereunder shall be in forms acceptable to Mortgagee and shall contain a provision requiring that the coverage evidenced thereby shall not be termined or materially modified without thirty (30) days prior written notice to Mortgage co. Mortgagor will obtain waiver of subrogation endorsements where applicable. Mortgagor will deliver to Mortgagee the originals of all insurance policies, or certificates thereof with cories of the original policies, and all additional, renewal or replacement policies not less the attenty (30) days prior to their respective expiration dates.
- C. The Mortgagor hereby in evocably assign to the Mortgagee all unearned premiums (current or future), and claims (current or future), of any policy or policies of insurance required to be maintained her under, or any renewals thereof, as further security for the payment of the indebtedness see red tereby. In the event of a foreclosure sale or other transfer of title to the Mortgaged rich is in extinguishment of the debt secured hereby, all right, title and interest of Mortgagor v, and to any policy or policies of insurance then in force will pass to the purchaser or grantee thereof subject to the rights of the Mortgagee hereunder, if any.
- Unless provided with evidence of the insurance coverage required by herein, Mortgagee, Mortgagee may purchase the required insurance at the expense of Mortgagor such insurance coverage, may, but need not, protect the inferest of the Mortgagor. The coverage purchased may, but need not, pay any claim made or any claim that is made by or against Mortgagor in connection with the Mortgaged Premi es. Insurance Mortgagor has obtained insurance as required herein. Any costs for the purch se of such insurance for the Mortgaged Premises, will be the responsibility of the Mortgagor, including interest and other charges which may be imposed in connection with the place ment of the insurance, until the effective date, the cancellation, or expiration of the insurance. The cost of such insurance will be added to the monthly payment or may be added to the total outstanding balance or obligation at Mortgagor may be able to obtain.
- E. In the event of any loss to or damage of the Mortgaged Premises by fire or other casualty, Mortgagor will give immediate notice thereof to Mortgagee and Mortgagee may thereupon make proof of loss or damage if the same is not promptly made by Mortgagor or the holder of the First Mortgage Lien. Subject to the rights of the holder of the First Mortgage Lien, all proceeds of insurance shall be payable to Mortgagee and each insurance company with which a claim is filed is authorized and directed to make payment thereof directly to Mortgagee. Provided an Event of Default has not occurred or is existing, Mortgagor shall be authorized and empowered to settle, adjust or compromise any claim for loss, damage or destruction under any policy or policies of insurance; provided, however, that if the same is not effected by Mortgagor within ninety (90) days of such loss or damage, Mortgagee may settle, adjust or compromise such claim without

notice to or the consent of Mortgagor. Subject to the rights of the holder of the First Mortgage Lien, all insurance proceeds shall, in the sole discretion of Mortgagec, be applied to the restoration, repair, replacement or rebuilding of the Mortgaged Premises or to and in reduction of any indebtodness secured by this Mortgage.

5. DAMAGE OR DESTRUCTION.

- ٨. In the event of damage to or destruction of the Mortgaged Premises, in whole or in part, Mortgagee shall make the proceeds received under any insurance policies available to Mortgagor for the rebuilding and restoration of the Mortgaged Premises, subject to the following conditions: (a) Mortgagor is not then in default under any of the terms, covenants and conditions of this Mortgage, or the Note; (b) all then-existing leases shall continue in full force and effect without reduction or abatement of rental (except during the period of untenantability); (c) Mortgagee shall be given satisfactory proof that such improvements have been fully restored or that by the expenditure of such proceeds will b) fully restored, free and clear of all liens, except as to the lien of this Mortgage and the First Mortgage Lien; (d) if such proceeds are insufficient to restore or rebuild the improvements, Mortgagor will deposit promptly with Mortgagee the amount deficient in urder to remore or rebuild the improvements; (e) if Mortgagor fails within a reasonable period of time, subject to delays beyond its control, to restore or rebuild the improvements, then Mortgagee, at its option, may restore or rebuild the improvements, for or on behalf of vior gagor and for such purposes may do all necessary acts, including using the funds deposited by Mortgagor pursuant to this Mortgage; (f) waiver of the right of subrogation shall be obtained from any insurer under such policies of insurance who, at that time, claims that no liability exists as to Mortgagor or the insured under such policies and (g) the excess o said insurance proceeds above the amount necessary to complete such restoration shall be applied as a credit upon any portion of the indebtedness secured hereby. In the cient any of the foregoing conditions are not or cannot be satisfied, then Mortgagee may use or apply the proceeds as a credit upon any portion of the indebtedness hereby secured. Under no circumstances shall Mortgagee become personally liable for the fulfillmer. it the terms, covenants and conditions contained in any leases with respect to the Mortaged Premises nor become obligated to take any action to restore the improvements comprising the Mortgaged Premises.
- B. In the event Mortgagee elects to apply such proceeds to resco ing the improvements, such proceeds shall be made available, from time to time, upon Mortgagee being furnished with satisfactory evidence of the estimated cost of such restoration and with architect's certificates, waivers of lien, contractors' sworn statements and oth revidence of cost and of payments as Mortgagee may reasonably require and approve, and if the estimated cost of the work exceeds ten percent (10%) of the original principal arcunt of the indebtedness secured hereby, with all plans and specifications for such rebuilding or restoration as Mortgagee may reasonably require and approve. No payment made prior to the final completion of the work shall exceed ninety percent (90%) of the value of the work performed, from time to time, and at all times the undisbursed balance or said proceeds remaining in the hands of the Mortgagee shall be at least sufficient to pay for the cost of completion of the work, free and clear of all liens.

6. CONDEMNATION.

A. All awards heretofore or hereafter made or to be made to Mortgagor by any governmental or other lawful authority for any taking, by condemnation or eminent domain of the whole or any part of the Mortgaged Premises or any improvement located thereon or any easement therein or appurtenant thereto are hereby assigned by Mortgagor to Mortgagee, which award Mortgagee is hereby authorized to collect and receive from the condemnation authorities, and Mortgagee is hereby authorized to give appropriate receipts and acquittances therefor, and Mortgagee shall use or apply the proceeds of such

award or awards in the same manner as is set forth in paragraph 5 above with respect to insurance proceeds received subsequent to a fire or other casualty affecting all or any part of the Mortgaged Premises. Mortgager covenant and agree to give immediate notice to Mortgagee of the actual or threatened commencement of any such proceedings under condemnation or eminent domain affecting all or any part of the Mortgaged Premises.

- B. In the event of any damage or taking by eminent domain of less than all of the Mortgaged Premises, Mortgagee shall make available the proceeds of any award received in connection with and in compensation for any such damage or taking for the purpose of rebuilding and restoring the Mortgaged Premises, subject to the terms and conditions set forth in subparagraph 5A, above. In the event any of the foregoing conditions are not or cannot be satisfied, then Mortgagee may use or apply the award as a credit against any portion of the indebtedness hereby secured. Under no circumstances shall Mortgagee become personally liable for the fulfillment of the terms, covenants, and conditions contained in any lease with respect to the Mortgaged Premises nor become obligated to take any action to restore the improvements.
- C. In the event Mortgagee elects to apply such award to restoring the improvements, the proceed. Thereof shall be made available upon the terms and conditions set forth in subparagraph, JB above.

7. MAINTENANCE OF MOXIGAGED PREMISES.

Mortgagor shall keep and main tail or cause to be kept and maintained, the Mortgaged Premises in good order, condition and repair and will make, or cause to be made, as and when necessary, all repairs, renewals and replacements, as and when necessary, structural and non-structural, exterior and interior, ordinary and extraordinary. Mo tgagor shall refrain from and shall not permit or suffer the commission of waste in or about the Mortgaged Premises nor remove, demolish or alter the structural character of any improvements at any time erected on the Mortgaged Premises otherwise upon the prior written consent of the Mortgagee. All rehabilitation to and construction performed in, on or about the Mortgaged Premises anall be in strict conformance with the provisions of paragraphs 5, 6, and 8 hereof.

To the extent required by Mortgagee or the holder of the First Mortgage Lien, Mortgager will promptly repair, restore, replace or rebuild any part of the Mortgaged Premises which may be damaged or destroyed by fire or other casualty or taken under power of eranent domain.

Mortgagor grant to Mortgagee and any person authorized to act on behalf of Mortgagee the right to enter upon the Mortgaged Premises and inspect the same at all reasonable times, provided however, nothing contained herein shall be construed as an obligation on the part of Mortgagee to make such inspections.

8. COMPLIANCE WITH LAWS.

Mortgagor shall promptly comply, or cause compliance with, all present and future laws, rules, ordinances, regulations and other requirements of each and every governmental authority having jurisdiction over the Mortgaged Premises with respect to the construction, rehabilitation, use or operation of the Mortgaged Premises or any portion thereof.

REPORTS.

10. SALES, TRANSFER, ASSIGNMENT OR ADDITIONAL ENCUMBRANCE.

Mortgagor shall not, without the prior written consent of Mortgagee first obtained, option, sell, contract to sell, assign, transfer, mortgage, pledge, or otherwise dispose of or encumber, whether by operation of law or otherwise, any or all of its interest in the Mortgaged Premises. Any such

option, sale, contract, assignment, transfer, mortgage, pledge or other disposition or encumbrance made without Mortgagee's prior written consent shall give Mortgagee the right, at its option, to accelerate the indebtedness secured by this Mortgage causing the full principal balance, accrued interest, to become immediately due and payable. If the owner of any portion of said beneficial interest is a partnership, the owner shall not suffer or permit any change in or substitution or withdrawal of fifty percent (50%) or greater interest in the owner without the prior written consent of the Mortgagee. If the owner of any portion of said beneficial interest is a corporation, the owner shall not suffer or permit any sale, assignment or other transfer of fifty percent (50%) or more of the stock of said owner, without the prior written consent of the Mortgagee.

Any such sale, transfer, assignment, pledge, conveyance or substitute made without the Mortgagee's prior written consent shall give the Mortgagee the right, at its sole option, to accelerate the indebtedness secured by this Mortgage causing the full principal balance and account interest to be immediately due and payable.

11. LATE CHARGE.

In the event any installment or other amount due hereunder shall be delinquent and remain unpaid as of the fifteenth (75th) day of the month in which such payment is due during the period when interest alone is payrbic, or as of the first (1st) day of the month following the month in which such payment is due during the period when installments of principal and interest are payable, there shall be due, at the option of the Mortgagee, a late charge equal to five percent (5%) of the amount of such delinquency

12. PREPAYMENT PRIVILEGE.

Privilege is reserved to prepay in whole or in one or more monthly installments or principal upon thirty (30) days' prior written notice to the Morigage without penalty, premium or charge.

13. PRIORITY OF LIEN: AFTER-ACQUIRED PRO? FATY.

- A. This Mortgage is and will be maintained as a val'd lien on the Mortgaged Premises, and shall at all times be prior and superior to any other non tage or trust deed securing any obligations now or hereafter becoming or falling due. Mortgagor will not, directly or indirectly, create or suffer or permit to be created, or to s and against the Mortgaged Premises, or any portion thereof, or against the rents, issue and profits therefrom, any lien, security interest, encumbrance or charge either prior or subordinated to or on a parity with the lien of this Mortgage.
- B. Mortgagor will keep and maintain the Mortgaged Premises free from a Vir. or for monies due and payable to persons furnishing labor or providing materials to the Mortgaged Premises in connection with any rehabilitation, construction, modification, repair or replacement thereof. If liens shall be filed against the Mortgaged Premises, Mo 22 gor agree to immediately cause the same to be discharged of record.
- C. In no event shall Mortgagor do, or permit to be done, or omit to do, or permit the omission of, any act or thing, the doing of which, or omission to do which, would impair the security of this Mortgage. Mortgagor shall not initiate, join in or consent to any change in any private restriction or agreement materially changing the uses which may be made of the Mortgaged Premises or any part thereof without the prior written consent of Mortgagee first obtained.
- D. All property of every kind acquired by Mortgagor after the date hereof which is required or intended by the terms of this Mortgage to be subjected to the lien of this Mortgage shall, immediately upon the acquisition thereof by Mortgagor, and without any further mortgage, conveyance, assignment or transfer, become subject to the lien and security of

this Mortgage. Mortgagor will do such further acts and execute, acknowledge and deliver such further conveyances, mortgages, security agreements, financing statements and assurances as Mortgagee shall reasonably require for accomplishing the purposes of this Mortgage.

E. If any action or proceeding shall be instituted to evict Mortgagor to recover possession of the Mortgaged Premises or any part thereof or to accomplish any other purpose which would materially affect this Mortgage or the Mortgaged Premises, Mortgagor will immediately upon service of notice thereof, deliver to Mortgagee a true copy of each petition, summons, complaint, notice of motion, order to show cause or other process, pleadings, or papers, however designated, served in any such action or proceeding.

14. MORTGAGEE'S RIGHT TO CURE,

If Nortgagor shall default in the performance or observance of any term, covenant, condition or obligation required to be performed or observed by Mortgagor under this Mortgage, then, without waiving of releasing Mortgagor from any of its obligations hereunder, Mortgagee shall have the right, but shall be under no obligation, to make any payment and/or perform any act or take such action as may be appropriate to cause such term, covenant, condition or obligation to be promptly performed or observed on behalf of Mortgagor. All sums expended by Mortgagoe in connection therewith, including act bout limitation reasonable attorney's fees and expenses, shall become immediately due and payable by Mortgagor upon written demand therefor with interest at the Default Interest Rate (as hortinafter defined) from the date of advancement by Mortgagor until paid and shall be secured by this biortgage. Mortgagor shall have the same rights and remedies in the event of nonpayment of any such sums by Mortgagor as in the case of a default by Mortgagor in the payment of the indebtedness ever enced by the Note.

15. DEFAULT INTEREST RATE.

The "Default Interest Rate" shall mean interest as a rate equal to two (2) percent above the thencurrent interest rate under the Note.

16. INDEMNIFICATION.

Mortgagor will protect, indemnify and save harmless Mortgagee on n and against all liabilities, obligations, claims, damages, penalties, causes of action, costs and expenses (including without limitation reasonable attorney's fees and expenses), imposed upon or incurred by or asserted against Mortgagee by reason of (a) the ownership of the Mortgaged Precuses or any interest therein or receipt of any rents, issues, proceeds or profits therefrom; (b) any accident, injury to or death of persons or loss of or damage to property occurring in, on or about the Mortgaged Premises or any part thereof or on the adjoining sidewalks, curbs, vaults and vault stace, if any, adjacent parking areas, streets or ways; (c) any use, nonuse or condition in, on or about the Mortgaged Premises or any part thereof or on the adjoining sidewalks, curbs, vaults an a vault space, if any, the adjacent parking areas, streets or ways; (d) any failure on the part of Mortgagor to perform or comply with any of the terms of this Mortgage; or (e) performance of any labor or services or the furnishing of any materials of other Property in respect of the Mortgaged Premises or any part thereof. Any amounts payable to Mortgagee by reason of the application of this paragraph shall become immediately due and payable and shall bear interest at the Default Interest Rate from the date loss or damage is sustained by Mortgagee until paid. The obligations of Mortgagor under this paragraph shall survive any termination or satisfaction of this Mortgage.

17. ASSIGNMENT OF RENTS AND LEASES.

As additional security for the obligations secured by this Mortgage, Mortgagor hereby transfer and assign to Mortgagee, all the rights, title and interest of Mortgagor as Lessors, in and to those certain leases identified by schedule in "Exhibit B" if attached hereto and made a part hereof and

any renewals or extensions thereof, and all future leases made by Mortgagor with respect to the Mortgaged Premises, and all of the rents, issues, proceeds and profits therefrom; provided that Mortgagor shall have the right to collect and retain such rents so lung as an Event of Default has not occurred or is existing. Notwithstanding the foregoing, the assignment of rents and leases made by Mortgagor hereunder shall be deemed a present assignment.

Mortgagee shall not be obligated to perform or discharge, nor does Mortgagee hereby undertake to perform or discharge, any obligation, duty or liability under any of such leases, and Mortgagor hereby agree to indemnify and hold Mortgagee harmless of and from all liability, loss or damage which it may incur under said leases or under or by reason of the assignment thereof and all claims and demands whatsoever which may be asserted against Mortgagee. Should Mortgagee incur any liability, loss or damage under said leases or under or by reason of the assignment thereof, or in the defense of any claims or demands made in connection therewith, the amount thereof, including without limitation reasonable attorney's fees and expenses, shall be secured hereby, and shall become immediately due and payable upon demand with interest at the Default Interest Rate from the dat, of advancement by Mortgagee until paid.

Upon the occurrence or existence of an Event of Default, Mortgagee, or any authorized agent of Mortgagee or any judicially-appointed receiver, shall be entitled to enter upon, take possession of and manage the Mortgaged Premises and to collect the rents therefrom including any rents past due. All rents collected by any of the foregoing parties shall be applied first to payment of the costs of management of the Mortgaged Premises and collection of rents, including without limitation receiver's fees, premiums or bonds and reasonable attorney's fees and expenses, and then to the sums secured by this Mortgage. Any such party shall be liable to account only for the rents actually received.

18. EVENTS OF DEFAULT.

Each of the following shall constitute an event of default ("Event of Default"):

- A. If a default, other than the punctual payment of all sums due under the Note, shall occur in the performance or observance of any covening, term, provision or condition of this Mortgage to be performed or observed by Mortgagor which default shall remain uncured after a date specified by Mortgagee in written notice to Mortgagor declaring such default but in no event shall such date be less than thirty (30) days from the effective date of such notice; or
- B. If an Event of Default (as therein defined) shall have occurred under the Note; or
- C. none
- D. If an Event of Default (as therein defined) shall have occurred under the acte or the mortgage evidencing and securing, respectively, the First Mortgage Lien, and such event of Default remains uncured upon the lapse of the appropriate grace period, it any, provided therein; or
- E. If an Event of Default shall have occurred under a loan agreement or other undertakings by Co-Borrower and Mortgagor, and such event of default results in the acceleration of the maturity of any indebtedness of Co-Borrower or Mortgagor to a third party; or
- F. If Mortgagor shall file a petition for protection from creditors under any of the provisions of the Federal Bankruptcy Code or State Insolvency laws or any creditor of Mortgagor shall file an involuntary petition against Mortgagor under any of the provisions of the Federal Bankruptcy Code or State Insolvency laws which is not dismissed within sixty (60) days after the filing of such involuntary petition; or

- If a lien for the performance of work or the supplying of materials is filed against the Mortgaged Premises and is not promptly discharged by Mortgagor; or
- J. If the Mortgaged Premises becomes subject to any lien not previously approved by Nortgagee, or any action by any holder of a junior lien, whether approved by Mortgagee or nut, to take possession, to collect rents, to foreclose, or to otherwise enforce rights against Nortgager or the Mortgaged Premises; or
- K. If, at any time during the term of the Note, the loan associated with this Mortgage becomes out of bab are and, within ten (10) days after notice thereof, Mortgagor have not deposited with Mortgagee the amount by which the loan is out of balance.
- L. If all or any part of the Mort aged Premises or any interest therein is sold, transferred, pledged or conveyed or become subject to a contract or option for sale of the Mortgaged Premises is sold, transferred, assigned pledged, or conveyed, in whole or in part (including without limitation a collaged) assignment thereof to any person other than Mortgagee), or if the owner of said beneficial interest is a partnership, any change in or substitution or withdrawal of fifty percent (50%) or greater interest in the owner, or if the owner is a corporation, any sale, assignment, riedge or other transfer of fifty percent (50%) or more of the stock of said owner,

then, in any such event, at the option of the Mortgagee, the entire run iid balance due on the Note and all accrued and unpaid interest thereon, and any other sums secured bereby shall become due and payable and thereafter each of said amounts shall bear interest at the Default Interest Rate. All costs and expenses incurred by, or on behalf of, Mortgagee (including without limitation reasonable attorney's fees and expenses) occasioned by an Event of Default by Mortgagor hereunder shall become immediately due and payable and shall bear interest at the Default Interest Rate from the date of advancement until paid. 19. RIGHTS, POWERS AND REMEDIES OF MORTGAGEE.

Upon the occurrence or existence of an Event of Default, Mortgagee may at any time thereafter, at its election and to the extent permitted by law:

- A. Proceed at law or in equity to foreclose the lien of this Mortgage as against all or any part of the Mortgaged Premises and to have the same sold under the judgment or decree of a court of competent jurisdiction.

Enter upon and take possession of the Mortgaged Premises or any part thereof by force, summary proceedings, ejectment or otherwise, and remove Mortgagor and all other persons and property therefrom, and take actual possession of the Mortgaged Premises, or any part thereof, personally or by its or their respective agents or attorneys, together with all documents, books, records, papers and accounts of Mortgagor and may exclude Mortgagor, their respective agents or servants, wholly therefrom and may, as attorney in fact and agent of Mortgagor, or in its or their own name and stead and under the powers herein granted: (i) hold, operate, manage and control the Mortgaged Premises and conduct the business thereof, either personally or by its agents, and with full power to use such measures, legal or equitable, as in its discretion or in the discretion of its successors or assigns may be deemed proper to necessary to enforce the payment or security of the avails, rents, issues and profits of the Mortgaged Premises, including actions for recovery of rents, actions in forcible detainer and actions in distress for rent, hereby granting full power and authority to exercise each and every right, privilege and power herein granted at any and all times bereafter, without notice to Mortgagor; (ii) cancel or terminate any lease or sublease for any cause or on any ground which would entitle Mortgagor to cancel the same; (iii) elect to dis. ff. r., any lease or sublease made subsequent to this Mortgage or subordinated to the lien acreof; (iv) extend or modify any then existing leases and make new leases, which extensiors, modifications and new leases may provide for terms to expire, or for options to lessees to extend or new terms to expire, beyond the maturity date of the indebtedness hereunder and the issuance of a deed or deeds to a purchaser at a foreclosure sale, it being understood and agreed that any such leases, and the options of other such provisions contained therein, shall or binding upon Mortgagor and all persons whose interest in the Mortgaged Premises are subject to the lien hereof and also upon the purchaser or purchasers at any foreclosure sale, no with standing any discharge of the mortgage indebtedness, satisfaction of any foreclosure decree or issuance of any certificate of sale or deed to any purchaser; (v) make an recessary or proper repairs, decorating, renewals, replacements, alterations, additions, better tents and improvements: to the Mortgaged Premises as Mortgagee may deem judicious to insure and reinsure the Mortgaged Premises and all risks incidental to Mortgagee's postersion, operation and management thereof and to receive all avails, rents, issues and profits. Mo tgagee shall not be under any liability for or by reason of such entry, taking of posterior, removal, holding, operation or management, except that any amounts so received shall be applied as hereinafter provided in this paragraph; and
- D. Make application for the appointment of a receiver for the Mortgaged Premises, whether such receivership be incident to a proposed sale of the Mortgaged Premises or otherwise, and Mortgagor hereby consent to the appointment of a receiver and agree not to oppose any such appointment and, further, agree that Mortgagee may be appointed the receiver of the Mortgaged Premises. and all rights or redemption from sale under any Order or Judgments of foreclosure of this Mortgage on behalf of Mortgagor, and all persons beneficially interested therein and each and every person acquiring any interest in or title to the Mortgaged Premises subsequent to the date of this Mortgage and on behalf of all persons to the extent permitted by the provisions of Section 5/3-1601(b), Code of Civil Procedure of Illinois, or any statute enacted in substitution there:

The proceeds of any sale of the Mortgaged Premises or any part thereof or interest therein, whether pursuant to foreclosure or power of sale or otherwise, and all amounts received by Mortgagee by reason or any possession, operation or management of the Mortgaged Premises or any part thereof, together with any off er sums at the time held by Mortgagee, shall be applied in the following order:

First:

To all costs and expenses of the sale of the Mortgaged Premises or any part thereof or any interest therein, or entering upon, taking possession of, removal from, holding, operating and managing the Mortgaged Premises or any part thereof, together with (a) the costs and expenses of any receiver of the Mortgaged Premises or any part thereof, appointed pursuant hereto; (b) the reasonable fees and expenses of anotherys, accountants and other professionals employed by Mortgagee or those engaged by any receiver; and (c) any indebtedness, taxes, assessments or other charges prior to the lien of this Mortgage, which Mortgagee may consider necessary or desirable to pay;
