Notwithstanding anything contained in the Trustee's Deed to which this Rider is attached, IT IS HEREBY AGREED AS FOLLOWS:

a). The legal description of the property being conveyed is as follows:

Unit 103 in THE HARBORSIDE CONDOMINIUM II, as delineated on survey of Lot 199 in Ancient Tree Unit One-G, a resubdivision of all of Outlot 6 in Ancient Tree Unit One-B, a subdivision recorded per Document Number 22970839 and also a part of Lot 1003 in Ancient Tree Unit One, being a subdivision of parts of the North-east one-quarter of the Southwest one-quarter and the Southeast one-quarter of the Northwest one-quarter of Section 8, Township 42 North, Range 12, East of the Third Principal Meridian, in Cook County, Illinois;

hereinafter referred to as "Parcel", which survey is attached as Exhibit "B" to Declaration of Condominium Ownership and of Easements, Restrictions and Covenants for THE HARBORSIDE CONDOMINIUM II, made by AMERICAN NATIONAL BANK AND TRUST COMPANY OF CHICAGO, not personally but solely as Trustee pursuant to Trust Agreement dated August 23, 1973 and known as Trust Number 32211, recorded in the Office of the Recorder of Deeds of Cook County, Illinois as Document Number 24-066-124, together with an unliquidated 3.48% interest in Parcel (excepting from Parcel all of the property comprising all of the units as set forth in said Declaration and survey).
