The City incurred costs and expenses when it demolished the unsafe structure on the Property on November 24, 2023, pursuant to an Order entered in the Circuit Court of Cook County, on May 1, 2015, in the case City of Chicago v. ALAN CHIN; WMC MORTGAGE CORP.; UNKNOWN OWNERS, AND NON-RECORD CLAIMANTS, Case No. 14 M1 402300. The structure was open, and vacant, and constituted an immediate and continuing hazard to the community. The required notice was posted to the structure, sent to the owners by certified mail, and published in local newspapers of general circulation. This lien in the amount of \$35,470.50 includes the expense of demolition and other related costs.

The owners and other interested parties have not reimbursed the City for its costs, leaving the balance of \$35,470.50 due, unpaid, and owing to the City. The City claims a lien on the Property in that amount with interest.
