THIS INDENTURE WITNESSETH, that the Grantors, **BENJAMIN J. KLINE and MEREDITH J. CONAGHAN**, of Barrington Hills, Illinois, as husband and wife, for and in consideration of Ten Dollars and zero cents (\$10.00), and other good and valuable considerations in hand paid, convey and warrant unto **BENJAMIN JOESPH KLINE, as Trustee of the BENJAMIN KLINE 2024 LIVING TRUST, and MEREDITH CONAGHAN, as Trustee of the MEREDITH CONAGHAN 2024 LIVING TRUST**, as Grantees, and unto all and every successor or successors in trust under said trust agreements, not as tenants in common and not as joint tenants but as tenants by the entirety, the following described real estate in the County of Cook and State of Illinois, to wit:

Lot 5 in Rolling Hills Subdivision Phase 1, being a subdivision in part of the Northwest ¼ of Section 18, Township 42 North, Range 9, East of the Third Principal Meridian, in Cook County, Illinois.

TO HAVE AND TO HOLD the said premises with appurtenances upon the trusts and for the uses and purposes herein and in said trust agreement set forth.

options to purchase the whole or any part of the reversion and to contract respecting the manner of fixing the amount of present or future rentals, to partition or to exchange said property, or any part thereof, for other real or personal property, to grant easements or charges of any kind, to release, convey, or assign any right, title, or interest in or about or easement appurtenant to said premises or any part thereof, and to deal with said property and every part thereof in all other ways and for such other considerations as it would be lawful for any person owning the same to deal with the same, whether similar to or different from the ways above specified, at any time or times hereafter.

In no case shall any party dealing with said Trustee in relation to said premises, or to whom said premises or any part thereof shall be conveyed, contracted to be sold, leased, or mortgaged by said Trustee, be obliged to see to the application of any purchase money, rent, or money borrowed, or advanced on said premises, or be obliged to see that the terms of this trust have been complied with, or be obliged to inquire into the necessity or expediency of any act of said Trustee, or be obliged or privileged to inquire into any of the terms of said trust agreement, and every deed, trust deed, mortgage, lease, or other instrument executed by said Trustee in relation to said real estate shall be conclusive evidence in favor of every person relying upon or claiming under any such conveyance, lease, or other instrument, (a) that at the time of the delivery thereof the trust created by this indenture and by said trust agreement was in full force and effect, (b) that such conveyance or other instrument was executed in accordance with the trusts, conditions and limitations contained in this indenture and in said trust agreement or in some amendment thereof and binding upon all beneficiaries thereunder, (c) that said Trustee was duly authorized and empowered to execute and deliver every such deed, trust deed, lease, mortgage, or other instrument, and (d) if the conveyance is made to a successor or successors in trust, that such successor or successors in trust have been properly appointed and are fully vested with all the title, estate, rights, powers, authorities, duties, and obligations of its, his, her or their predecessor in trust.



And the said Grantor hereby expressly waives and releases any and all right or benefit under and by virtue of any and all statutes of the State of Illinois, providing for the exemption of homesteads from sale on execution or otherwise.
