

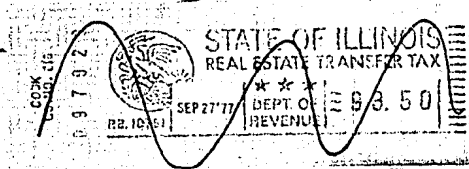
This Indenture, Made this 24 139 406 20th day of August, 1977

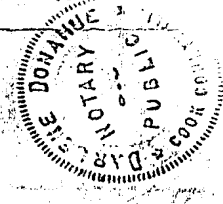
