the South 50 feet thereof), in Cook County, Illinois.

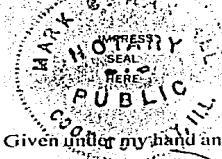

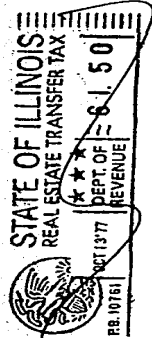
