Subject to building lines, covenants and restrictions, easements of record, if any.

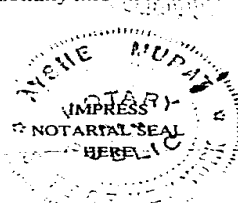
