Any offset or claim that Borrower may have now or in the future against Lender will not relieve Borrower from making the full amount of all payments due under the Note and this Security Instrument or performing the covenants and agreements secured by this Security Instrument.

2. Acceptance and Application of Payments or Proceeds.

(a) Acceptance and Application of Partial Payments. Lender may accept and either appropriation of Partial Payments. Partial Payments in its sole discretion in accordance with this Section 2. - (a) Insurance Requirement; Coverages. Borrower must keep the improvements now existing or subsequently erected on the Property insured against loss by fire, hazards included within the term "extended coverage," and any other hazards including, but not limited to, earthquakes, winds, and floods, for which Lender requires insurance. Borrower must maintain the types of insurance Lender requires in the amounts (including deductible levels) and for the periods that Lender requires. What Lender requires pursuant to the preceding sentences can change during the term of the Loan, and may exceed any minir un coverage required by Applicable Law. - (b) Failure to Maintain insurance. - (e) Insurance Settlements; Assignment of Proceeds. If Borrower abandons the Property, Lender may file, negotiate, and settle any available insurance claim and related matters. If Lender files, negotiates, or settles a claim, Borrower agrees that any insurance proceeds may be made payable directly to Lender without the need to include Borrower as ar, additional loss payee. Lender may use the insurance proceeds either to repair or restore the Property (as provided in Section 5id)) or to pay amounts unpaid under the Note or this Security Instrument, whether or not then due.
- 6. Occupancy. Burrower must occupy, establish, and use the Property as Borrower's principal residence within 60 days after the execution of this Security Instrument and must continue to occupy the Property as Borrower's principal residence for at least one car after the date of occupancy, unless Lender otherwise agrees in writing, which consent will not be unreasonably withheir, or unless extenuating circumstances exist that are beyond Borrower's control.

Unless Lenger determines pursuant to Section 5 that repair or restoration is not economically feasible, Borrower will promptly repair the Poperty if damaged to avoid further deterioration or damage.

If insurance or condemnation proceeds are paid to Lender in connection with damage to, or the taking of, the Property, Borrower will be responsible for repairing or restoring the Property only if Lender has released proceeds for such purposes. Lender may disburse proceeds for the repairs an a restoration in a single payment or in a series of progress payments as the work is completed, depending on the size of the pair or restoration, the terms of the repair agreement, and whether Borrower is in Default on the Loan.
