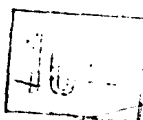

TO HAVE AND TO HOLD the same unto said parties of the second part for or, not in tenancy in common, but in joint tenancy.

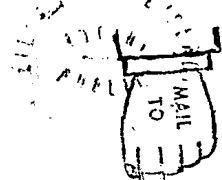
SUBJECT TO: General Real Estate Taxes for 1977 and Subsequent years.
