The City incurred cost and expenses when it demolished the unsafe structure on the Property on January 18, 2024, pursuant to an Order entered in the Circuit Court of Cook County, on June 29, 2023, in the case CITY OF CHICAGO v. TM REO FUND, LLC, at al., Case No. 19 M1 401620. The structure was open, vacant, and constituted an immediate and continuing hazard to the community. The required notice was posted to the structure, sent to the owners by certified mail, and published in local newspapers of general circulation. This lien in the amount of \$26,921.00 includes the expense of demolition and other related costs.
