### **COUNT I**

On October 9, 2019, the claimant entered into a written agreement with said owner to provide legal representation before the Cook County Assessor and/or Board of Review to contest the 2019 assessed value of the premises, for compensation totaling one-half (50%) of the 2019 tax savings achieved as a result of claimant's efforts. The agreement further provided that claimant would be entitled to a life on the premises in the event the fee was not paid when due.

On January 10, 2020 clain ant completed said legal representation before the Cook County assessor and/ or Board of Review, by successfully reducing the 2019 assessed value from \$37,260 to \$34,742, resulting in a 2019 tax saving of \$737 and a fee due claimant of \$368.50.

There remains, unpaid and owing to the claimant, the amount (1\$775.78, for which, with interest, the claimant claims a lien on the premises described in Exhibit "A".


