Grantor hereby grants to Grantee, their successors and assigns, as rights and easements appurtenant to the above lescribed real estate, the rights and easements for the benefit of raid property set forth in the aforementioned Declaration or condominium, and Grantor reserves to itself, its successors and essigns, the rights and easements set forth in said Declarations for the benefit of the remaining property described therein.

This deed is subject to all rights, easements, restrictions, conditions, covenants and reservations contained in said Declaration the same as though the provisions of said Declaration were recited and stipulated at length herein.
