- THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 1 (THE REVERSE SIDE OF THIS TRUST DEED):

  1. Murgagors shall (a) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (b) keep said premises in good condition and repair, without waste, and free from mechanic's or other liens or claims for lien not expressly subordinated to the lien hereof; (c) pay when due any indebtednees which may become be repaired to the formation of the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of life discharge of Such prior lien to Trustee or to Indexe of the Contract (10) complete within a reasonable time any lutiliding or buildings or the promises and the unit process control to the promises and the upon the material alterations in said premises except as required by law or municipal ordinance.

  2. Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, severy service charges, and other charges against the premises when due, and shall, upon written request, furnish to Trustee or to holders of the contract duplicate receipts therefor. To prevent default hereafted and the material alterations in the manner provided by statute, any tax or assessment which Mustgagors may desire to context.

  2.
