This document is recorded for the purpose of amending the Declaration of Covenants, Conditions, Restrictions and Easements (hereafter the "Declaration") for the Courtland Square Homeowners' Association (hereafter the "Association"), which Declaration was recorded as Document Number 25053432 and re-recorded as Document 25217261 in the Office of the Recorder of Deeds of Cook County, Illinois, and was amended by the First Amendment recorded as Document 94467592 and the Second Amendment recorded as Document 99975618 in the Office of the Recorder of Deeds of Cook County, Illinois and covers the property (hereafter the "Property") legally described in Exhibit A, which is attached hereto and made a part hereof.

This Amendment is adopted pursuant to the provisions of Article VII, Section 7.01 of the Declaration. Said section provides that the Declaration may be amended by an instrument signed by not less than three-fourths (3/4) of the Board of Directors of the Courtland Square Homeowners' Association ("Board"). No amendment shall become effective until recorded.

RECITALS

WHEREAS, by the Declaration recorded in the Office of the Recorder of Deeds of Cook County, Illinois, the Property has been subjected to the easements, restrictions and covenants contained therein; and

WHEREAS, the Board desires to amend the Declaration to provide for the orderly operation of the Property; and

WHEREAS, the following amendment has been approved by three-fourths (3/4) of the members of the Board, which approvals are attached hereto and made a part hereof; and

NOW, THEREFORE, the Declaration is hereby amended as follows:

1. Article III, (new) Section 3.12

3.12 Leasing Units. Except as stated below, the rental or leasing of Units in the Association is prohibited and subleasing shall not be permitted, effective with the recording of this Amendment.

(a) Owners as of the effective date of this Amendment may lease their Unit as long as they remain the owner of the Unit, and those Units will be "Grandfathered". The Unit's Grandfathered status will terminate upon the sale or transfer of any part of the ownership of the Unit.

(b) At all times a copy of the current lease for the Unit must be on file with the Association. Background checks for all tenants are required and must be provided with the lease. Each lease shall be in writing and shall provide such lease shall be subject to the terms of this Declaration and any failure of the lessee to comply with the terms of this Declaration shall be a default under the lease. A lessee shall be bound by the provisions hereof regardless of whether the lease specifically refers to this Declaration. All tenants shall acknowledge in writing that they have received copies of the Rules and Regulations of the Association and a copy of the written receipt shall be submitted to the Board. No Unit may be leased or licensed for hotel or transient purposes.

(i) Hardship Exemption. In order to meet special situations and to avoid undue hardship or practical difficulties, the Board may, but is not required to, grant permission to a Unit Owner to lease his Unit to a specified lessee for a period of not less than six (6) months nor more than one (1) year on such reasonable terms as the Board may establish. Such permission may be granted by the Board only upon written application by the Unit Owner to the Board giving the reasons the Unit Owner wishes to be considered for a hardship. The Board shall respond to each application in writing within thirty (30) days of the submission thereof. All requests for extension of the original lease must also be submitted to the Board in the same manner as set forth for the original application. The Board has sole and complete discretion to approve or disapprove any Unit Owner's application for a lease or extension of a lease. The Board's decision shall be final and binding. Any lease approved by the Board shall be subject to the Declaration, By-Laws and rules and regulations governing the Association.

(ii) Family Member Exemption. Occupancy of a Dwelling Unit by an "Immediate Family Member" of a Unit Owner is permitted and shall not constitute a lease as defined under this Amendment, even if there is no written memorandum or agreement executed between the parties. "Immediate Family Member" shall be defined as parents, brothers, sisters, grandparents, and children (whether natural or adopted) of the Unit Owner.

(iii) Any Unit being leased out in violation of this Amendment or any Unit Owner and/or tenant found to be in violation of the Rules and Regulations adopted by the Board of Directors may be subject to a flat or daily fine to be determined by the Board of Directors upon notice and an opportunity to be heard.

(iv) In addition to the authority to levy fines against the Unit Owner for violation of this Amendment or any other provision of the Declaration, By-Laws or Rules and Regulations, the Board shall have all rights and remedies, including an action for injunctive and other equitable relief, or an action at law for damages.

(v) Any action brought on behalf of the Association and/or the Board of Directors to enforce this Amendment shall subject the Unit Owner to the payment of all costs and attorneys' fees at the time they are incurred by the Association.

(vi) All unpaid charges as a result of the foregoing shall be deemed to be a lien against the Unit and collectible as any other unpaid regular or special assessment, including late fees and interest on the unpaid balance.

(vii) The Board of Directors of the Association shall have the right to lease any Association owned Units and said Units shall not be subject to this Amendment.

(c) To the extent an Individual Condominium Building has adopted or shall adopt an Amendment to its Declaration of Condominium that conflicts with the provisions of this Section, the provisions of the Condominium Building's Amendment shall supersede this Section.

2. Article III, (new) Section 3.13

3.13 Maximum Occupancy. The Maximum Occupancy of each Unit shall be as below. Units which exceed these limits may be subject to a monthly surcharge. The overoccupancy fee, if any, is to be set by the individual Condominium Association Boards of Managers.

(c) To adopt administrative rules and regulations governing the administration, management, operation and use and occupancy of the Community Areas, Units, Buildings and Common Elements, and to amend such rules and regulation from time to time;

4. This Amendment shall be effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois.

5. Except to the extent expressly set forth hereinabove, the remaining provisions of the Declaration shall continue in effect without change.
