### FINAL JUDGMENT ORDER

This matter comes before this Court for hearing on Defendant's Motion for an Extension of Time and for hearing on Plaintiffe Verified Petition for Fees and Costs ("Plaintiff's Petition"), Plaintiff appearing by counsel *via* Zoom video conference, Defendant failing to appear, it is hereby ordered:

- 1. This Court waited until 10:20 a.m. before calling this matter and neither Defendant nor Defendant's counsel appeared in open court or via Zoom video conference.
- 2. Over Plaintiff's objection, Defendant's Motion for an Extension of Time is granted, and this Court considered Defendant's Answer to Petition for Attorney's Fees ("Defendant's Answer") in ruling on Plaintiff's Petition.
- 3. In ruling on Plaintiff's Petition, this Court also considered the (i) time expended by Plaintiff's counsel, (ii) the reasonableness of the hourly rate for the work performed, (iii) the reasonableness of the amount of time expended for the work performed, and (iv) the amount in controversy and the nature of the action.
- 4. This Court reviewed, in open court, unredacted copies of the invoices attached to Plaintiff's Petition and provided Defendant an opportunity to review and/or object to any or all of Plaintiff's time entries and expense entries.

5. Having failed to appear, Defendant failed to object to any of Plaintiff's time entries

and expense entries. Defendant admits the reasonableness of Plaintiff's counsels' hourly rates and

admits such rates are customary and reasonable in this locale for legal professionals with experience

and skill of Plaintiff's counsels. See, Defendant's Answer at \$\ 2 \[ \] 2 \[ \] sic \, 4-5.

6. This Court finds that the hourly rates charged by Plaintiff's counsels were reasonable

for the work performed, and the time expended by Plaintiff's counsels was reasonable considering the

amount in controversy and the nature of the action; provided, however, the time entry for Adam J.

Findlay dated March 2 2023, is reduced from 1.1 hours to .1 hours.

7. This Fine! adaptent Order amends the money damages portion of the Eviction Order
