FINAL JUDGMENT ORDER

This matter coming to be heard or the Complaint to Condemn filed by the Department of Transportation of the State of Illinois (the 'Department") to acquire a temporary easement for construction purposes for a period not to exceed five (5) years, or until completion of construction operations, whichever occurs first, across and upon real property designated as Parcel 0L73333TE, and described on the attached Exhibit A; and to ascertain the just compensation to be paid for this acquisition, the Court having been fully advised in the premises:

HEREBY FINDS

- 1. The Department is represented by Kwame Raoul, Attorney General of the State of Illinois, and Antonia S. Pritchard, Special Assistant Attorney General c/o Wilker Wilcox Matousek, LLP, One North Franklin Street, Suite 3200, Chicago Illinois 60606.
- The Cook County Treasurer is represented by Arias G. Dalianas of Franczek P.C.,
 South Wacker Drive, Suite 3400, Chicago, Illinois 60606.
- 3. The Department filed this condemnation suit on January 12, 2022, as part of its roadway project to improve South Wood Street from 141st Street to 161st Street in Dixmoor. The

Department seeks to acquire a temporary easement referred to as Parcel 0L73333TE from property located on South Wood Street, with common address 1801 W. 142nd Street, in Dixmoor (the "Subject Property").

- 4. Parcel 0L73333TE is part of a larger parcel located at 1801 W. 142nd Street, in Dixmoor, Cook County, Illinois ("Subject Property").
- 5. The Court has jurisdiction over the parties and over the Subject Property in this proceeding.
- 6. On May 25, 2022, the Court entered judgment by default against Unknown Owners and Non-Record Claimants.
- 7. On Januar 24. 2023, the Court entered judgment by default against defendants:
 (1) Heirs of Geraldine Justice; (2) Jandra L. Sims f/k/a Sandra L. Justice; (3) Jeffrey R. Justice;
 (4) Cook County Land Bank Authority; and (5) New Beginnings Christian Church.
- 8. Pursuant to the Department's Motion for Immediate Vesting of Title, on March 28, 2022, this Court entered an order determining preliminary compensation to be \$500.00 for the Department's acquisition of Parcel 0L73333TE, and the Department deposited this amount with the County Treasurer of Cook County on May 17, 2027.
- 9. On May 25, 2022, the Court entered an Order Vesting Title that vested the Department with a temporary easement for construction purposes for a period not to exceed five (5) years, or until completion of construction operations, whichever occurs first, scross and upon real property designated as Parcel 0L73333TE, and authorized the Department to take possession of said Parcel.
- 10. On June 27, 2023, the Court entered an order granting the Department's Motion for Summary Judgment on Amount of Final Just Compensation and found the amount of final just compensation to be \$500.00.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED THAT:

A. The full and final just compensation including compensation for the property rights being taken and for any and all damage to the remainder, including costs to cure, whether claimed or unclaimed, arising out of the acquisition of a temporary easement to Parcel 0L73333TE, as said real property being fully described in the attached Exhibit A, is FIVE HUNDLED DOLLARS (\$500.00).

B. The Final Judgment Order entered on today's date in the amount of \$500.00 as full and final just compensation for the acquisition of Parcel 0L73333TE, be and the same is hereby declared satisfied and the judgment entered on today's date against Plaintiff is hereby released.

C. The Order Vesting True entered on May 25, 2022, vesting Plaintiff with a temporary easement to Parcel 0L73333TE and authorizing Plaintiff to take possession of said Parcel is hereby confirmed.

D. The Order granting Plaintiff's Motion for Summary Judgment on Amount of Final Just Compensation entered on June 27, 2023 is confirmed in all respects.

E. This Court shall maintain jurisdiction to enforce this order and to adjudicate the distribution of the final just compensation.

F. This is a final judgment order and there is no just reason for delaying either enforcement or appeal or both of this order.
